Subject: Resolution Authorizing Release of Surplus Tax Deed 06A-127 Sale Proceeds

Recommendation

It is recommended that the Board of County Commissioners (Board) approve the attached resolution authorizing release of Surplus Tax Deed 06A-127 sale proceeds in the amount of \$335,764.17 to Eleodoro Gonzalez, Trustee, who was the titleholder on the date of the above-referenced sale and is entitled to the resulting proceeds.

Scope

The attached resolution authorizes release of surplus tax deed sale proceeds in accordance with provisions of the Florida Statutes.

Fiscal Impact/Funding Source

None. All property taxes owed were collected at the time of tax certificates being sold and/or at time of tax deed sale. Surplus funds are paid from net proceeds of the tax deed sale.

Track Record/Monitor

The proposed release of these surplus tax deed sale proceeds is being done in accordance with Section 197.582, Florida Statutes.

Background

Miami-Dade County presently holds \$335,764.17 in excess proceeds from the sale of a tax deed for delinquent taxes on or about August 10, 2006 on a property described as follows:
