RESOLUTION APPOINTING INTERIM BOARD OF TRUSTEES TO THE METRO MIAMI ACTION PLAN TRUST; AND APPROVING THE NOMINATING COUNCIL PROCEDURES FOR SELECTION OF THE BOARD OF TRUSTEES

WHEREAS, on November 20, 2008, this Board adopted Resolution No. R-1271-08, which created the eleven member Metro Miami Action Plan Trust Oversight Review Board ("Oversight Board"); and

WHEREAS, pursuant to that resolution the Board also removed all of the Board of Trustees of Metro Miami Action Plan Trust ("MMAP") and further directed the MMAP Nominating Council to convene within ten days of the date of that resolution; and

WHEREAS, this Board expressed concerns that an interim Board of Trustees be appointed in order to avoid a lengthy period of time elapsing by which MMAP is without a Board of Trustees; and

WHEREAS, this Board further agreed that the interim Board of Trustees could be selected from the membership of the Oversight Board; and

WHEREAS, on December 10, 2008, the Nominating Council convened a meeting of its members pursuant to Section 2-503(a) of the Code of Miami-Dade County ("Code") to recommend the names of the interim MMAP Board of Trustees; and

WHEREAS, Robert Holland, Esq., Reverend Richard P. Dunn, and Reverend Walter T. Richardson were previously appointed by the Board to serve as members of the Oversight Board; and

WHEREAS, Robert Holland, Esq., Reverend Richard P. Dunn, and Reverend Walter T. Richardson have agreed that they will serve, subject to this Board approval, as interim Board of Trustees in lieu of serving on the Oversight Board and the Oversight Board membership shall be reduced from 11 to 7 members and quorum of such board shall be the majority of such membership; and

WHEREAS, the Nominating Council voted unanimously to nominate and recommend the appointment of Robert Holland, Esq., Miguel De Grandy, Esq. Reverend Richard P. Dunn, Reverend Walter T. Richardson and Reverend Canon Richard Livingston Marquese-Barry, whose resumes are attached hereto as Exhibit A, to serve as interim MMAP Board of Trustees; and

WHEREAS, the Nominating Council, pursuant to the Code, has also developed procedures for the selection of the Board of Trustees, which are attached hereto as Exhibit B and which are subject to the approval of this Board,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, the Board:

Section 1. Pursuant to the Code hereby appoints the following persons to serve as interim MMAP Board of Trustees:

- a. Robert Holland, Esq. Private Attorney;
- b. Rev. Richard Dunn, President of People United to Lead the Struggle for Equality (P.U.L.S.E.);

- c. Reverend Walter T. Richardson, Senior Pastor at Sweet Home Missionary Baptist Church;
- d. Miguel De Grandy, Esq., Private Attorney; and
- e. Reverend Canon Richard Livingston Marquese-Barry, St. Agnes Episcopal Church. The above-named interim Board of Trustees shall serve in this capacity for a period not to exceed ninety (90) days.
- Section 2. Pursuant to the Code hereby approves the Nominating Council's procedures for the selection of the MMAP Board of Trustees.
- Section 3. Directs the MMAP Interim Board of Trustees and the Oversight Board to work cooperatively to achieve the goals of County Resolution No. R- 1271-08 and the MMAP Ordinance codified at Section 2-501, et. seq.
- Section 4. The recitals in this resolution are incorporated by reference and hereby amend Resolution No. R-1271-08.

Dr. Walter T. Richardson is a leading voice in South Florida for social justice. His ability to equate the black religious experience with the social concerns of the black community has been recognized as a needed methodology for change. Because of his vital ministry the Sweet Home Baptist Church, where he pastors, has grown from a part-time two-Sunday a month congregation of less than 200 member to a full-time staffed ministry with two morning services each Sunday and a membership of over two thousand persons. The Sweet Home church is involved in holistic healing for the family in that it offers ministries involving singles, married couples, youth, the elderly and peer counseling at all levels. Ministries are also in operation dealing with chemical dependency and literacy. Sweet Home is also a racially integrated congregation with native-American blacks, Spanish, Haitians, Whites and representation from several Caribbean Islands. Dr. Richardson is also acclaimed as a leading adjunct professor at the St. Thomas University where he teaches religion. Walter T. Richardson is also nationally known for his musical talent, having recorded with several choirs and artists, including the Florida Mass Choir as vocalist and musician. Having worked for more than twenty years in executive management with Sears, Roebuck and Company, Dr. Richardson resigned that job to devote his full time to the holistic ministry of the South Dade community.

Mr. De Grandy obtained his Bachelors degree in Business Administration from the University of Florida at 20 years of age. Mr. De Grandy's years of experience as the ranking minority member on the House Judiciary Committee, the Reapportionment Committee and his service on the Select Committee on Agency Rules has given him a unique perspective on the regulatory and administrative processes in Florida.

Upon retirement from the Florida Legislature in 1994, Mr. De Grandy became Chairman of the Governmental and Administrative law group in the Miami office of the Greenberg Traurig law firm. In 2001, Mr. De Grandy resigned as a Principal Shareholder at Greenberg Traurig to form his own firm.

REDISTRICTING AND REAPPORTIONMENT

As a member of the Florida House of Representatives, Mr. De Grandy took a leading role in the 1992 Legislative and Congressional Redistricting in Florida.

When the legislature reached impasse on the enactment of a Reapportionment and Redistricting Plan, Mr. De Grandy, became the lead plaintiff and co-counsel in the case of <u>De Grandy vs Whetherell</u>, a federal action based on the Voting Rights Act which sought to ensure that minority communities throughout the state would have the ability to elect representatives of their choice.

The De Grandy plaintiffs prevailed in their litigation and the court imposed the De Grandy Plan for Florida's Congressional Districts. Prior to 1992 there had not been a black congressperson elected in Florida for a 100 years. As a result of De Grandy's plan, Florida now enjoys diversity in its congressional representation.

Mr. De Grandy has been often quoted by the media as an "expert" on Redistricting and Voting Rights Act issues. He has also served in several capacities on issues dealing with redistricting and the Federal Voting Rights Act issues including:

• Appointed by Speaker John Thrasher as lead trial counsel to The Florida House of Representatives in Fouts v. Mortham, a

federal case filed in the Southern District of Florida in 1998 challenging several state and congressional minority seats wherein the three-judge panel granted the Legislature's joint motion to dismiss.

- Appointed by Florida House Speaker Tom Feeney as lead counsel to advise the House on redistricting, reapportionment, and Voting Rights Act issues during the 2002 reapportionment cycle.
- Served as lead trial counsel in 2002 to the House in Martínez v. Bush, a Federal Voting rights Act lawsuit in which a three-judge panel entered judgment in favor of the House and Senate.

METRO MIAMI ACTION PLAN TRUST NOMINATING COUNCIL OPERATING PROCEDURES

The Metro Miami Action Plan Trust Nominating Council ("Nominating Council"), having been duly established by the Board of County Commissioners of Miami-Dade County, Florida pursuant to Section 2-503(a) of the Code of Miami-Dade County, hereby adopts, subject to the final approval of the Board of County Commissioners, the following operating procedures for the solicitation, screening, interviewing, and recommending for the appointment of the best qualified candidates who will fill the vacancies on the MMAP Board of Trustees.

Article I Function & Duties

The sole function of the Nominating Council shall be to solicit, screen, interview and recommend for appointment the best qualified candidates who will fill the vacancies on the MMAP Board of Trustees to the Miami-Dade Board of County Commissioners.

Article II

Procedures for the Solicitation, Screening, Interviewing, and Recommending for Appointment

The Nominating Council shall comply with the following procedures for the solicitation, screening, interviewing, and recommending for the appointment of the best qualified candidates who will fill the vacancies on the MMAP Board of Trustees:

<u>Solicitation</u>: The Nominating Council shall ensure all efforts are made to solicit qualified candidates to serve on the MMAP Board of Trustees whenever there is a vacant position. At a minimum, the Nominating Council will advertise all vacant positions in publications of wide distribution in Miami-Dade County, including but not limited to The Miami Herald, El Nuevo Herald, Miami Times, Haite en Marche, Miami Daily Business Review, and on the Miami-Dade County's website. Included in each advertisement, the Nominating Council shall set the deadlines for application submissions to the Clerk's Office. All advertisements and application forms will be approved by the Nominating Council.

Upon receipt of each candidate's applications, Miami-Dade County staff assigned to the Nominating Council shall prepare an application matrix that will be distributed to the Nominating Council.

Screening: Prior to making any recommendation to the Board of County Commissioners, the Nominating Council shall screen each candidate, including but not limited to reviewing each application to ensure that the candidates meet the minimum qualifications to become members of the Board of Trustees and select each candidate to be interviewed. In addition, background checks will be conducted by Miami-Dade County of each of the candidates. The screening of each candidate will be conducted at duly noticed meetings of the Nominating Council.

<u>Interview</u>: Following the screening process described herein, the Nominating Council shall conduct in person interviews of each of the candidates. The purpose of the interview is further aide in the screening of candidates.

Recommendation to the Board of County Commissioners: Upon the final selection of the candidates who will be recommended to the Board of County Commissioners, the appointed Commissioner, who serves as a member of the Nominating Council, will sponsor a resolution for the approval of the slate of candidates by the Board of County Commissioners.

Article III *Meetings*

All meetings of the Nominating Council shall comply with Florida's Government in the Sunshine laws. Public notice of all meetings shall be given in accordance with State and local requirements. Meetings shall be open to the public. The records, reports, transcripts, minutes, agenda and other documents which are made available to or prepared for or by the Partnership shall be made available for public inspection and copying at a single location consistent with Chapter 119 of the Florida Statutes.

Article IV Amendments

These operating procedures may be amended or repealed by the Board of County Commissioners.
