Subject: Resolution Amending Resolution No. R-939-97 to Change the Account Title and the Existing Signature Authorities on the Trust Account for Bond Payments

Recommendation

It is recommended that the Board of County Commissioners approve the attached resolution to amend resolution No. R-939-97 to change the account title and signature authorities on the Dade County Corrections account at the Regions Bank in Miami, Florida.

Scope

This resolution only impacts the Miami-Dade Corrections and Rehabilitation Department.

Fiscal Impact/Funding Source

This resolution does not have any fiscal impact.

Track Record/Monitor

This account will be monitored by Maxine Harris, Commander, Budget and Finance Bureau.

Background

The Miami-Dade Corrections and Rehabilitation Department (MDCR) has established a Bond Escrow Account at the Regions Bank in Miami, Florida in order to deposit all cash bonds received on behalf of offenders that have bonded out of jail. The bond payments received at the Pre-Trial Detention Center or the Turner Guilford Knight Correctional Center are deposited into the Bond Escrow Account and later drawn out by check to pay the bond charges to the Miami-Dade County Clerk of Courts and other applicable jurisdictions. The issued checks are signed by two authorized MDCR staff.

With the recent reorganization of the MDCR table of organization for FY 2008-09, persons authorized to sign checks have changed. As a result, the signature authorities on file with Regions Bank require updating to reflect the new department structure. Accordingly, the authorized signatures are those persons occupying the following positions:
