

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE FEBRUARY 20, 2009 "FLAGAMI FIESTA" SPONSORED BY THE UNITY INTERNATIONAL FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,155.00 TO BE FUNDED FROM THE DISTRICT 6 IN-KIND RESERVE FUND

WHEREAS, Unity International Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the February 20, 2009 "Flagami Fiesta" event in an amount not to exceed \$1,155.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Flagami Fiesta" is a free event which brings the local community together through live entertainment, art exhibits, children's games and a dominoes contest; and

WHEREAS, the Unity International Foundation, Inc. is a not-for-profit organization; and

WHEREAS, the "Flagami Fiesta" event is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,155.00 of the in-kind services shall be funded from the District 6 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the February 20, 2009 "Flagami Fiesta" event in an amount not to exceed \$1,155.00 to be funded from the District 6 In-kind Reserve Fund.





Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization the Unity International Foundation, Inc. for their "Flagami Fiesta" event held on February 20, 2009.
