RESOLUTION NO. R-549-09

RESOLUTION AUTHORIZING CONVEYANCE OF A PORTION OF COUNTY-OWNED PROPERTY TO CITY OF MIAMI AS ROAD RIGHT-OF-WAY, AND AUTHORIZING THE EXECUTION OF A COUNTY DEED FOR SUCH PURPOSES

WHEREAS, the Miami-Dade Homeless Trust is leasing property located at 1398 S.W. 1st Street, on which an affordable housing development and branch library have been built; and

WHEREAS, as a condition to issuing a Certificate of Occupancy to the development and library, the City of Miami requires that Miami-Dade County convey a portion of the County-owned property as right-of-way for a radius return on the corner of S.W. 1st Street and 14th Avenue; and

WHEREAS, that portion of the County-owned property is not needed for any County purpose,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Authorizes the conveyance to the City of Miami of a portion of county-owned property for use as City right-of-way, located at 1398 SW 1st Street, and legally described in Exhibit "A" of the County Deed and shown in Exhibit "B", both of which are attached hereto and incorporated herein by reference.

Section 2. Authorizes the Mayor to execute said County Deed in substantially the form attached hereto.

Section 3. Directs the Mayor or the Mayor’s Designee to cause said County Deed to be delivered to the City of Miami.

The Prime Sponsor of the foregoing resolution is Commissioner Bruno A. Barreiro. It was offered by Commissioner **Jose “Pepe” Diaz**, who moved its adoption.
