

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The countywide in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, the Zoological Society of Florida, for their "Feast with the Beasts" event held on March 6, 2009.

In-kind services have been requested in an amount not to exceed \$4,065 from the Miami-Dade Park and Recreation Department for the use of (4) four generators, a break out box, (10) ten 100ft extension cords, (6) six spider boxes and technical services, \$1,515 from the Miami-Dade Water and Sewer Department for the use of (3) light towers and \$1,259 from the Miami-Dade Police Department for police services for a total in-kind amount of \$6,839. This event will be funded from the countywide in-kind reserve fund.

In FY 2008-09, the Zoological Society of Florida has received \$10,000 from District 4 discretionary reserve, \$5,000 from District 8 discretionary reserve, and \$2,500 from District 9 discretionary reserve. In addition, as part of Resolution 261-09, the organization received \$2,020 from the Countywide in-kind reserve and as part of Resolution 262-09, the organization received \$2,020 from the Countywide in-kind reserve.
