RESOLUTION NO. R-418-09

RESOLUTION ACCEPTING CONVEYANCE OF PROPERTY LOCATED ON CARD SOUND ROAD, FOLIO NUMBER 30-9913-000-0014, IN MIAMI-DADE COUNTY, FLORIDA, FOR PUBLIC PURPOSES AND IN CONNECTION WITH THE SETTLEMENT OF A LAWSUIT WHERE MIAMI-DADE COUNTY SOUGHT TO QUIET TITLE

WHEREAS, on July 8, 2008, Key’s Gateway Investment Corporation filed against Miami-Dade County in the Circuit Court of the Eleventh Judicial Circuit in and for Miami-Dade County, Florida, Case No. 08-38984 (CA-09), a Complaint to Quiet Title and for Declaratory Relief in connection with property located on Card Sound Round, referenced as folio number 30-9913-000-0014 and further identified in the property sketch attached as Exhibit “A,” including a portion of Miami-Dade County right-of-way; and

WHEREAS, on September 15, 2008, Miami-Dade County filed a counterclaim against Key’s Gateway Investment Corporation to quiet title in Miami-Dade County, and for injunctive relief based upon code violations; and

WHEREAS, on December 15, 2008, the Eleventh Judicial Circuit entered a ruling favorable to the County quieting title in the County’s name to a portion of the property, including the roadway and a two-foot shoulder, and additionally, granting injunctive relief to require the removal of an illegal dock; and

WHEREAS, after such ruling, Key’s Gateway Investment Corporation dismissed its case against Miami-Dade County, removed the illegal structure, and has tendered a quit claim deed,

which is attached hereto as Exhibit “B” and made a part hereof, conveying to Miami-Dade County all of its property interests in the entire property; and

WHEREAS, upon consideration of the foregoing, this Board finds and determines that the acceptance of such conveyance would be in the public’s best interest,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board ratifies and adopts those matters set forth in the foregoing recitals, that the conveyance of the above-described property be and the same is hereby approved and accepted, and the Director of the Public Works Department is authorized and directed to cause said instruments to be filed for record among the Public Records of Miami-Dade County, Florida; provided, however, that it is specifically understood that neither this Board nor Miami-Dade County is obligated to construct any improvements within the above described property or right-of-way.

The foregoing was offered by Commissioner **Joe A. Martinez**, who moved its adoption. The motion was seconded by Commissioner **Jose “Pepe” Diaz** and upon being put to a vote, the vote was as follows:





Commence at the Northwest corner of Section 13, Township 59 South, Range 39 East in Miami-Dade County, Florida; thence S 89°37'24" E along the North line of said Section for 3019.75 feet to the intersection of said North line of Section 13, Township 59 South, Range 39 East with the centerline of Card Sound Road as shown on Township Survey Map of Township 59 South, Range 39 East, as prepared by Metropolitan Dade County Public Works Department dated December, 1970; thence S 30°43'59" E along said centerline for 283.11 feet; thence S 13°21'56" E continuing along said centerline for 1261.61 feet; thence S 43°30'59" E for 1435 feet; thence S 43°30'59" E continuing along said centerline for 83 feet to the Point of Beginning; thence S 43°30'59" E continuing along said centerline for 243.43 feet; thence S 46°29'02" W for 75.00 feet; thence N43°30'59"W for 243.43 feet; thence N 46°29'02" E for 75.00 feet to the Point of Beginning.
