

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE MARCH 6-8, 2009 “CHRIST THE KING INTERNATIONAL FESTIVAL AND CARNIVAL” SPONSORED BY THE ARCHDIOCESE OF MIAMI INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$960.00 TO BE FUNDED FROM THE DISTRICT 9 IN-KIND RESERVE FUND

WHEREAS, the Archdiocese of Miami, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the March 6-8, 2009 “Christ the King International Festival and Carnival” in an amount not to exceed \$960.00 (see attached Fee Waiver/In-kind Service Application); and

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for the item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive fee waiver for in-kind services is being requested by a not-for-profit organization the Archdiocese of Miami, Inc. for the "Christ the King International Festival and Carnival" held on March 6-8, 2009.
