The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, the Municipio de San Luis, Pinar de Rio en el Exilio, Inc., for the "Verbena San Luiseña" event held on March 29, 2009.

In-kind services have been requested in an amount not to exceed \$1,870 from the Miami-Dade Park and Recreation Department for the use of a medium show mobile, a 25 KW generator and an electrical power distribution panel. This event will be funded from the District 6 in-kind reserve fund.

In FY 2008-09, the Municipio de San Luis, Pinar de Rio en el Exilio, Inc. has received no county funding for this event.
