Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization the First Christian Church (Disciples of Christ) of Homestead, Inc., for their "Family Unity Service" event held on March 29, 2009.

In-kind services have been requested in an amount not to exceed \$2,466 from the Miami-Dade Park and Recreation Department for the use of a large show mobile. This event will be funded from the District 8 in-kind reserve fund.
