

Subject: District Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services request is being requested from a not-for-profit organization the Nuevo Caminar Ministerio Catolico, Inc., for their "Seminar for Substance Abuse Recovery" at Greynolds Park scheduled for April 17-19, 2009.

In-kind services have been requested in an amount not to exceed \$1,127 from the Miami-Dade Park and Recreation Department for use of campground at Greynolds Park. This event will be funded from the District 6 in-kind reserve fund.
