



RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE JULY 4, 2009 “42ND ANNUAL FOURTH OF JULY CELEBRATION” SPONSORED BY THE GFWC WHISPERING PINES WOMAN’S CLUB, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,045.00 TO BE FUNDED FROM THE DISTRICT 8 IN-KIND RESERVE FUND

WHEREAS, GFWC Whispering Pines Woman’s Club, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the July 4, 2009 “42nd Annual Fourth of July Celebration” in an amount not to exceed \$1,045.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the “42nd Annual Fourth of July Celebration” is an annual event that commemorates the independence of the United States of America and is celebrated by a parade, old-fashioned barbecue, live music and games; and

WHEREAS, proceeds from the barbecue will be used to cover costs for the event as well as tree-plantings and other school improvements at local elementary schools; and

WHEREAS, GFWC Whispering Pines Woman’s Club, Inc. is a not-for-profit organization; and

WHEREAS, the “42nd Annual Fourth of July Celebration” is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,045.00 of the in-kind services shall be funded from the District 8 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes in-

kind services from the Miami-Dade Park and Recreation Department for the July 4, 2009 “42nd Annual Fourth of July Celebration” in an amount not to exceed \$1,045.00 to be funded from the District 8 In-kind Reserve Fund.

Recommendation

The Office of Strategic Business Management (OSBM) has reviewed the attached in-kind request and recommends for this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for the funding of this request.

Background

A waiver for in-kind services has been requested by a not-for-profit organization, the GFWC Whispering Pines Woman's Club, Inc., for their "42nd Annual Fourth of July Celebration" event scheduled for July 4, 2009.
