Recommendation

It is recommended that the Board of County Commissioners (BCC) approve the attached resolution designating a portion of Miami-Dade County owned property at NW 35 Avenue as road right-of-way from NW 46 Street north for approximately 520 feet, in Section 21, Township 53 South, Range 41 East, Miami-Dade County, Florida.

Scope

The subject property is located within Commission District 2.

Fiscal Impact/Funding Source

There is no fiscal impact associated with this item.

Background

The subject property was acquired by General Services Administration (GSA) in 1991. GSA has developed plans to use the property as the new location for the Construction Trades Shop. In order to satisfy a zoning requirement that before a building permit is issued a road right-of-way must be dedicated, GSA has requested that the portion of the subject property that falls within the zoned right-of-way be designated as road right-of-way.

The additional road right-of-way dedication will improve traffic safety in the vicinity of the property and to this area of Miami-Dade County.

The Directors of the GSA and Public Works Department agree upon the public benefits to be derived from the designation of this parcel for road right-of-way purposes



RESOLUTION DESIGNATING A PORTION OF MIAMI-DADE COUNTY OWNED PROPERTY FOR ROAD RIGHT-OF-WAY AT NW 35 AVENUE FROM, NW 46 STREET NORTH FOR APPROXIMATELY 520 FEET, IN SECTION 21, TOWNSHIP 53 SOUTH, RANGE 41 EAST

WHEREAS, the Directors of the Departments of Public Works and General Services Administration have recommended that a portion of County-owned land at NW 35 Avenue be designated as public road right-of-way, and the County Manager has concurred in said recommendation as outlined in the accompanying memorandum, a copy of which is incorporated herein by reference,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board hereby designates and declares the following described lands at NW 35 Avenue, owned by Miami-Dade County, as public road right-of-way, as set forth in the accompanying memorandum from the County Manager:

Legal Description

A portion of the SE 1/4 of the SW 1/4 of the NW 1/4 of Section 21, Township 53 South, Range 42 East more particularly described as follows:

The East 35 feet of the SE 1/4 of the SW 1/4 of the NW 1/4 of said Section 21, less the North 145 feet and less the South 80 feet thereof;

And

The West 10 feet of the East 35 feet of the South 80 feet of the SE 1/4 of the SW 1/4 of the NW 1/4 of said Section 21, less the South 35 feet thereof;

And

The external area formed by a 25 radius concave to the NW and tangent to the West line of the East 35 feet of the SW 1/4 of the NW 1/4 of said Section 21 and tangent to the North line of the South 35 feet of the NW 1/4 of said Section 21.


