RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE APRIL 17-18, 2009 "JP'S ANNUAL SOFTBALL TOURNAMENT" SPONSORED BY METRO DAWGS POLICE SOFTBALL ORGANIZATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$818.00 TO BE FUNDED IN PART FROM DISTRICT 11 AND IN PART FROM DISTRICT 10 IN-KIND RESERVE FUNDS

WHEREAS, Metro Dawgs Police Softball Organization, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the April 17-18, 2009 "JP's Annual Softball Tournament" in an amount not to exceed \$818.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "JP's Annual Softball Tournament" is a fundraiser to benefit the children of fallen officers; and

WHEREAS, Metro Dawgs Police Softball Organization, Inc. is a not-for-profit organization; and

WHEREAS, the "JP's Annual Softball Tournament" is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$818.00 of the in-kind services shall be funded in part from District 11 and in part from District 10 In-kind Reserve Funds,

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item to move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, the Metro Dawgs Police Softball Organization, Inc., for their "JP's Annual Softball Tournament" event held on April 17-18, 2009.

In-kind services have been requested in an amount not to exceed \$818 from the Miami-Dade Park and Recreation Department for Indian Hammocks Park fees. This event will be funded in part from District 11 (\$409) and in part from District 10 (\$409) in-kind reserve funds.

In FY 2008-09, the Metro Dawgs Police Softball Organization, Inc. has received no county funding for this event.
