Subject: Resolution Authorizing Allocation of Funds pursuant to FY 2009 Empowerment Zone (EZ)
Request for Applications (RFA) EZ-03-2009

The following item was amended at the June 10, 2009 meeting of the Housing and Community Development Committee to correct for scrivener's errors in Exhibit 1. On handwritten page three, which is Exhibit 1, the agency ranked as #20 (The Thinking Child Academy) received a score of 640, and not 40. Similarly, the agency ranked #25 (Ecumenical Developments) received a score of 520, and not 20.

RECOMMENDATION

It is recommended that the Board of County Commissioners (BCC) authorize the Mayor or the Mayor's designee to award up to \$3.5 million of US Department of Housing and Urban Development (US HUD) federal Empowerment Zone (EZ) grant funds to 26 eligible economic development projects listed in Exhibit 1, in substantially the form herein. These projects serve EZ residents and are a result of the FY 2009 RFA process.

Furthermore, staff concurs with the Empowerment Zone Strategies Alliance (EZSA), that in the event a designated agency or business is unable to enter into its contractual obligation in a timely fashion, staff shall be authorized to negotiate a contract with the next highest scoring agency (i.e. the "next-in-line" project). It is further recommended that should any of the contracted agencies fail to complete their scope of activity in a timely fashion, the funds shall be placed in a revolving loan fund which will be managed by the Office of Community and Economic Development (OCED) or its agent. Such fiscal agent, if needed, shall be selected by OCED from the existing agencies currently managing Community Development Block Grant funded revolving loan funds. The purpose of this fund is to provide low interest capital to EZ businesses.

SCOPE

The EZ covers specific census tracts in the following ten neighborhoods: 1) Central Business District/Seaport; 2) Airport; 3) Melrose; 4) Allapattah/Civic Center; 5) Overtown; 6) East Little Havana; 7) Wynwood; 8) Liberty City/Model City; 9) Homestead; and 10) Florida City. In addition, the EZ covers three developable sites: 1) Opa Locka Airport (a 902-acre site); 2) Northside/Poinciana Industrial Center (a 259-acre site) and 3) Homestead/Florida City (a 621-acre site).

Exhibit 1 includes information on the Commission District, EZ neighborhood, funding recommendation and type of activity for each recommended project.

FISCAL IMPACT

There is no fiscal impact to the County. The EZ program sunsets on December 31, 2009 and OCED is working within US HUD's guidelines to ensure that these remaining dollars are awarded and spent by the sunset date. Failure to do so will require the US HUD to recapture any remaining unencumbered funds.

MONITORING

The OCED/EZ Program Manager will perform monthly site inspections, while compliance staff will perform quarterly desk audits to ensure that contractors meet the requirements of the contract which include among other issues, appropriate insurance; sufficient progress, monthly reporting, and the filing of annual audits.

BACKGROUND

The "Empowerment Zone and Enterprise Community (EZ/EC) Initiative" was established as a strategy to create jobs and business opportunities in the most economically distressed areas of America's inner cities. In 1999, the Board approved a Memorandum of Understanding (MOU) between the County and the Miami Dade Empowerment Trust, Inc. (MDET) that delegated authority to MDET to govern, direct, and implement the ten year Empowerment Zone Strategic Plan. However, the County remained as the "Lead Entity" for all EZ grant funds. On July 10, 2007, the MOU between MDET and the County was terminated. On March 11, 2008, pursuant to County Ordinance 08-56, the County designated OCED to continue and monitor the EZ program.

On March 17, 2009, the Board approved Resolution R-311-09, authorizing the FY 2009 EZ Request for Allocations (RFA) in the amount of no more than \$3.5 million in federal EZ funds. The RFA was released March 23, 2009 and 46 proposals were received, of which 33 met the requirements outline in the RFA. An evaluation selection committee (consisting of representation from EZSA, EZ Neighborhood Assemblies, and County staff) met and recommended the projects in Exhibit 1. If any of the agencies in Exhibit 1 are unable to enter into a contract, the County will negotiate a contract with the next-in-line agency(s) in Exhibit 2. However, in the event that any of the contracted agencies fail to complete their scope of services in a timely manner, the funds shall be recaptured from the contracted entity and reallocated to the revolving loan fund.

The revolving loan fund will be managed by the OCED, or the County's contracted agent, and will be available to qualified small and medium size businesses that are located, or looking to locate, within the Miami-Dade EZ. Applications and funding recommendations will be developed through a process that contains input and approval from the EZSA and oversight by OCED. The revolving loan fund will serve to ensure that funds will be preserved for local use in the County's EZ communities. All funding recommendations from the revolving loan fund will be presented to the Board of County Commissioners for final approval.

RESOLUTION NO. R-915-09

RESOLUTION ALLOCATING AND EXPENDING FUNDS PURSUANT TO THE FY 2009 EZ REQUEST FOR APPLICATIONS (RFA) EZ-03-09 AS SET FORTH IN EXHIBIT 1 AND AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO DEVELOP A LOAN FUND WITH RECAPTURED OR REMAINING FUNDS FROM EZ-03-09 AS AVAILABLE; AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO EXECUTE ALL CONTRACTS, AGREEMENTS AND AMENDMENTS NECESSARY TO CARRY OUT THE ALLOCATIONS; FURTHER AUTHORIZING THE MAYOR OR THE MAYOR'S DESIGNEE TO EXECUTE THE CANCELLATION PROVISIONS CONTAINED THEREIN

WHEREAS, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

WHEREAS, in 1999, the Miami Dade Board of County Commissioners (BCC), approved a Memorandum of Understanding (MOU) between Miami Dade County (the County), and the Miami Dade Empowerment Trust (MDET), that delegated authority to MDET to govern, direct, and implement the ten year Empowerment Zone Strategic Plan; and

WHEREAS, the Memorandum of Understanding (MOU), between the Miami Dade Empowerment Trust (MDET) and the County was terminated, on July 10, 2007; and

WHEREAS, on March 11, 2008 pursuant to County Ordinance 08-56 the Office of Community and Economic Development (OCED) was designated as the implementing arm of the Empowerment Zone to continue to monitor the EZ program until expiration of its designation; and

WHEREAS, the Federal designation of the Empowerment Zone ends December 31, 2009; and

WHEREAS, pursuant to Resolution No. R-311-09, approved by the BCC, on May 14, 2009, the Empowerment Zone Evaluation/Selection Committee recommended that OCED enter into negotiations with selected Proposers for no more than \$3.5 million in U.S. HUD EZ funds as a result of the FY 2009 Request For Application (RFA-EZ-03-2009) funding; and

WHEREAS, the Empowerment Zone Evaluation Selection Committee recommended, in the event that a Proposer is not able to conclude negotiations or complete their scope of service in a timely manner consistent with the contract requirements, that OCED can negotiate with the next highest ranked Proposer; and

WHEREAS, the Evaluation Selection Committee recommends, that in the event that subsequent Proposers are not able to conclude negotiations and performance within a timely manner that the affected allocation shall be redirected to a Revolving Loan Fund (the Fund) for the purpose of providing low interest capital to Empowerment Zone agencies; and

WHEREAS, the Fund will be managed by the appropriate designated staff and will be available to qualified small and medium size businesses that are located or looking to locate within the Miami-Dade Empowerment Zone. Applications and funding recommendations will be developed through a process that contains input and approval from the Empowerment Zone Strategies Alliance, oversight by the Mayor or Mayor's designee and final authorization by the Board of County Commissioners; and

WHEREAS, the Board supports prudent and effective activities that enhance the Empowerment Zone communities,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the Board:

Section 1. This Board allocates and authorizes the expenditure of funds pursuant to the FY 2009 EZ Request for Applications (RFA) EZ-03-09 as set forth in Exhibit 1 and authorizes the Mayor or the Mayor's designee to develop a loan fund with recaptured or remaining funds from EZ-03-09 as available; authorizes the Mayor or the Mayor's designee to execute all contracts, agreements and amendments necessary to carry out the allocations; and further authorizes the Mayor or Mayor's designee to execute the cancellation provisions therein.

Section 2. Authorizes the Mayor or the Mayor's designee, County Attorney, and Clerk of the Board to take whatever actions are necessary to effect the purposes of this resolution.

The foregoing resolution was offered by Commissioner **Audrey M. Edmonson**, who moved its adoption. The motion was seconded by Commissioner **Dorrin D. Rolle** and upon being put to a vote, the vote was as follows:
