RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE JULY 20, 2009 "GROUNDBREAKING CEREMONY" SPONSORED BY COLOMBIAN AMERICAN COALITION OF FLORIDA, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$680.00 TO BE FUNDED FROM THE DISTRICT 11 IN-KIND RESERVE FUND

WHEREAS, Colombian American Coalition of Florida, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the July 20, 2009 "Groundbreaking Ceremony" in an amount not to exceed \$680.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Groundbreaking Ceremony" is an event at Westwind Park to celebrate the groundbreaking for the cultural plaza that will recognize Colombian culture and its local impact; and

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, Colombian American Coalition of Florida, Inc., for their "Groundbreaking Ceremony" event held on July 20, 2009.

In-kind services have been requested in an amount not to exceed \$680 from the Miami-Dade Park and Recreation Department for the use of risers, a podium, sound system and technician services. This event will be funded from the District 11 in-kind reserve fund.

In FY 2008-09, Colombian American Coalition of Florida, Inc., received no county funding for this event.
