





**RESOLUTION DEDICATING MIAMI-DADE FIRE RESCUE  
STATION 31 LOCATED AT 17050 N.E. 19 AVENUE, NORTH  
MIAMI BEACH IN HONOR OF FIREFIGHTER CATHERINE  
WALL**

**WHEREAS**, Firefighter Catherine Wall has served Miami-Dade County residents with honor and distinction over a 25 year career; and

**WHEREAS**, during her career, Firefighter Wall distinguished herself as a courageous and caring firefighter and paramedic, working at busy stations most of her career, often going back after a call and helping people in need with medical care, food and clothing; and

**WHEREAS**, Firefighter Wall dedicated thousands of hours of her time to helping those in need, by providing hurricane relief and assisting individuals afflicted with muscular dystrophy, cancer and cerebral palsy; and

**WHEREAS**, Firefighter Wall was raised in North Miami Beach and worked for much of her career there as a paramedic and firefighter; and

**WHEREAS**, Firefighter Wall has been battling leukemia, which has sidelined her career and forced her to stop working in the field for medical treatment; and

**WHEREAS**, this proposed facility dedication is located in County Commission District 4,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Finds that Firefighter Catherine Wall has made a direct, significant lifetime contribution to this community, and approves the dedication of the Miami-Dade Fire

Rescue Station 31 located at 17050 N.E. 19 Avenue, North Miami Beach in honor of Firefighter Catherine Wall.

**Section 2.** Directs the Mayor or Designee to install suitable signage and/or markers dedicating Miami-Dade Fire Rescue Station 31 in honor of Firefighter Catherine Wall.

The Prime Sponsor of the foregoing resolution is Commissioner Sally A. Heyman. It was offered by Commissioner **Sally A. Heyman**, who moved its adoption. The motion was seconded by Commissioner **Dorrin D. Rolle** and upon being put to a vote, the vote was as follows:
