

RESOLUTION APPROVING THE CITY OF MIAMI'S CO-DESIGNATION OF SW 4TH STREET FROM SW 62ND COURT TO SW 63RD COURT AS "JUAN MANUEL 'NANITO' VAZQUEZ WAY"

WHEREAS, on June 25, 2009, the Miami City Commission adopted Resolution R-09-0305, which designated SW 4th Street from SW 62nd Court to SW 63rd Court as "Juan Manuel 'Nanito' Vazquez Way," in recognition of his contributions to the City of Miami, a copy of which is attached and incorporated by reference; and

WHEREAS, SW 4th Street from SW 62nd Court to SW 63rd Court is a city street located in the City of Miami; and

WHEREAS, the City of Miami wants the County to install signage indicating this co-designation on County street signs and traffic signal masts arms; and

WHEREAS, this co-designation is located in County Commission District 6,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Approves the City of Miami's co-designation of SW 4th Street from SW 62nd Court to SW 63rd Court as "Juan Manuel 'Nanito' Vazquez Way."

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public

Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Commissioner Rebeca Sosa. It was offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:

A RESOLUTION OF THE MIAMI CITY COMMISSION CODESIGNATING SOUTHWEST 4TH STREET FROM SOUTHWEST 62ND COURT TO SOUTHWEST 63RD COURT, MIAMI, FLORIDA, AS "JUAN MANUEL 'NANITO' VAZQUEZ WAY;" FURTHER DIRECTING THE CITY MANAGER TO INSTRUCT THE DIRECTOR OF PUBLIC WORKS TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICES.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. Southwest 4th Street from Southwest 62nd Court to Southwest 63rd Court, Miami, Florida, is codesignated as "Juan Manuel 'Nanito' Vazquez Way."

Section 2. The City Manager is directed to instruct the Director of Public Works to transmit a copy of this Resolution to the Departments of Police, Fire-Rescue, Solid Waste, Miami-Dade County Public Works, and the United States Postal Service.

Section 3. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.{1}

Footnotes:

{1} If the Mayor does not sign this Resolution, it shall become effective at the end of ten calendar days from the date it was passed and adopted. If the Mayor vetoes this Resolution, it shall become effective immediately upon override of the veto by the City Commission.
