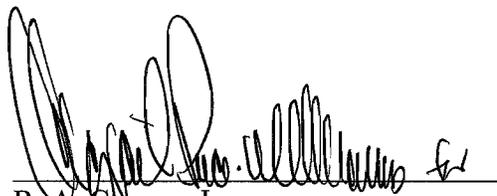

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE AUGUST 8, 2009 "BACK-2-SCHOOL SUMMER SPLASH" SPONSORED BY THE PORTRAIT OF EMPOWERMENT, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,780.00 TO BE FUNDED FROM THE DISTRICT 1 IN-KIND RESERVE FUND

**WHEREAS**, Portrait of Empowerment, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the August 8, 2009 "Back-2-School Summer Splash" in an amount not to exceed \$1,780.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the purpose of the "Back-2-School Summer Splash" is to alleviate some of the costs associated with the purchase of back-to-school supplies by low-income families; and

**WHEREAS**, Portrait of Empowerment, Inc. is a not-for-profit organization; and

**WHEREAS**, the "Back-2-School Summer Splash" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,780.00 of the in-kind services shall be funded from the District 1 In-kind Reserve Fund,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the August 8, 2009 "Back-2-School Summer Splash" in an amount not to exceed \$1,780.00 to be funded from the District 1 In-kind Reserve Fund.

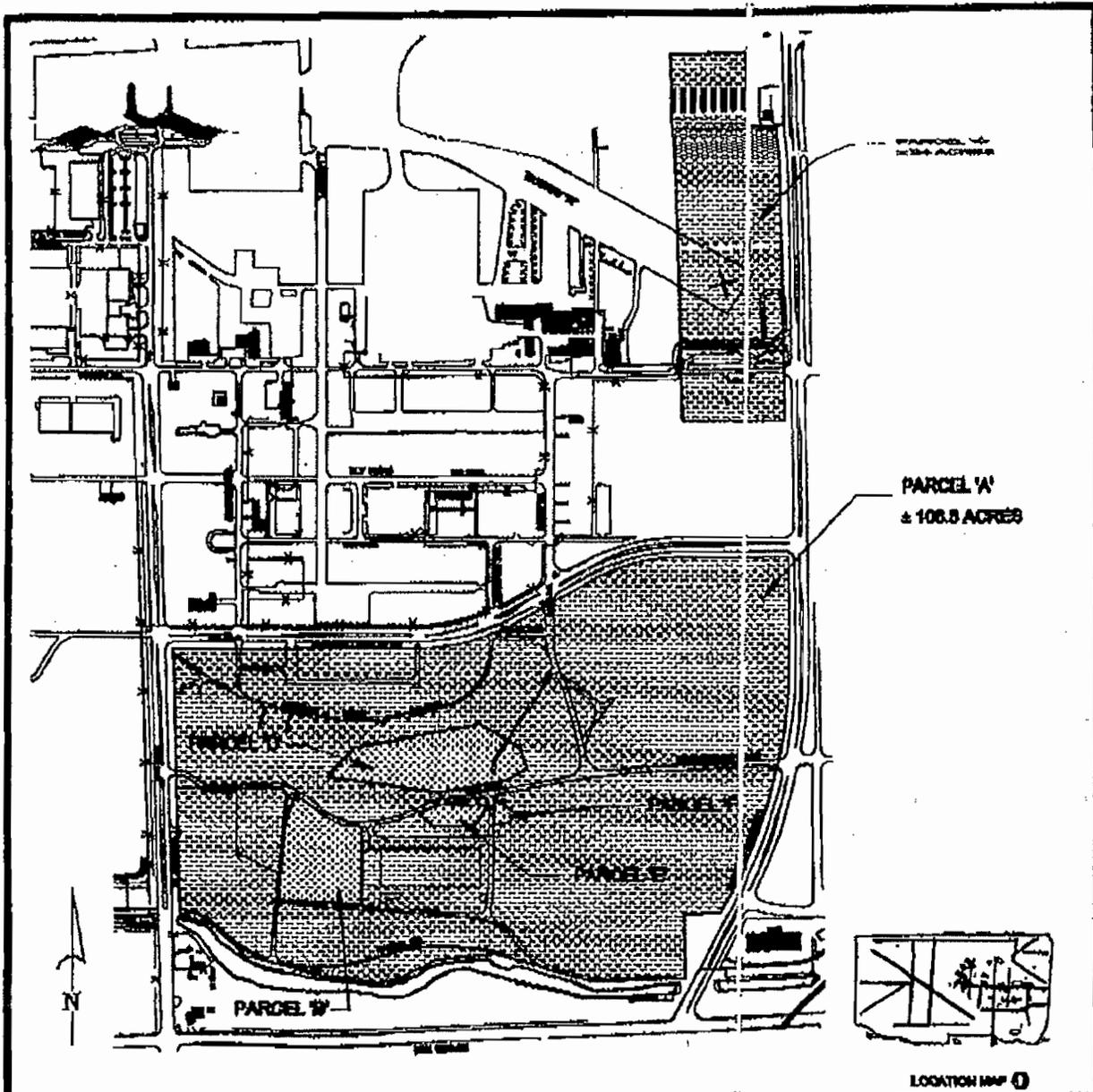

## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Portrait of Empowerment, Inc., for their "Back-2-School Summer Splash" event held on August 8, 2009.

In-kind services have been requested in an amount not to exceed \$1,780 from the Miami-Dade Park and Recreation Department for the use of a medium showmobile and a generator. This event will be funded from the District 1 in-kind reserve fund.

In FY 2008-09, Portrait of Empowerment, Inc., received \$6,000 from the District 1 discretionary reserve fund and \$5,000 from the District 2 discretionary reserve fund.
