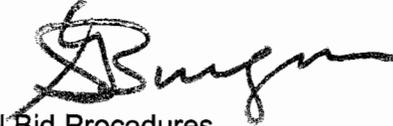

Subject: Resolution Waiving Formal Bid Procedures

**Recommendation**

It is recommended that the Board of County Commissioners waive competitive bidding procedures for the attached contracts to purchase goods and services pursuant to Section 2-8.1 of the County Code and Section 5.03(D) of the Home Rule Charter, in the best interest of Miami-Dade County. **Contract amounts and department allocations represent the maximum spending authority based on utilization. This action does not guarantee that the total contract amount/value will be expended by County departments and/or agencies.**

**Scope**

The impact of the items in the accompanying Bid Waiver Package is countywide in nature.

**Fiscal Impact/Funding Source**

**Funding will be expended only if departmental budgets can support the expenditures approved in their Resource Allocation Plan adopted annually by the Board.**

**Track Record/Monitor**

There are no known performance issues with the vendors recommended for award in the accompany Bid Waiver Package. Each department's contract manager is reflected in the accompanying Bid Waiver agenda item.

**Delegated Authority**

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise in their discretion subsequent options-to-renew (OTR) and extend contracts for purchase of goods and services in accordance with the terms and conditions of the contracts listed in the accompanying Bid Waiver Package.

**Section 1 SOLE SOURCE**

A sole source purchase is the procurement of a good or service under Administrative Order 3-38 for which there is no other vendor who can compete to provide the good or service, and an equal product or service is not available from any other supplier.

**Contract No.:** SS9148-4/15

**Contract Title:** **GuideSTAR Software Licenses, Maintenance, Support, Training, and Professional Services Agreement**

**Description:** Requesting waiver of formal bid procedures and approval to award a Sole Source contract for the Miami-Dade Police Department (MDPD) to acquire the GS/1 Eagle software licenses, maintenance, support, training, and professional services provided by GuideSTAR Technologies Inc. Staff is recommending an initial two year term with four one year options-to-renew.

**Contract Term:** Two years with four, one-year options-to-renew

**Contract Amount:** \$475,000

\*Each option-to-renew term is valued at \$200,000. Should the County choose to exercise the four one-year options-to-renew, the cumulative value will be \$1,275,000.

**JUSTIFICATION**

Approval is requested to award this contract to GuideSTAR Technologies, Inc. to provide the Miami-Dade Police Department (MDPD) the ability to acquire GS/1 Eagle software licenses, maintenance, support, training, and professional services. This contract will provide MDPD with a collaborative intelligence analysis software system. The GS/1 Eagle software will be utilized by the Narcotics Bureau, Homeland Security, and Robbery Divisions to facilitate collaboration in detecting and interdicting potential criminal and security threats, as well as investigating and resolving criminal incidents. The software capabilities include housing and organizing information, inferring connections between individuals and events, and using automated functionality for collaboration at intra and inter-departmental levels. Expanded use in other areas within MDPD is anticipated in the future.

The GS/1 Eagle software is proprietarily developed and owned by GuideSTAR Technologies Inc. It is in the best interest of the County to establish the sole source contract with GuideSTAR Technologies to obtain a collaborative intelligence analysis solution that meets the operational and security needs of MDPD.
