RESOLUTION NO. R-1207-09

RESOLUTION CO-DESIGNATING SW 180TH STREET AT THE INTERSECTION OF SW 137TH AVENUE AS “SERENA LAKES BLVD.”

WHEREAS, SW 180th Street is a County road located in unincorporated Miami-Dade County; and

WHEREAS, this proposed co-designation is located in County Commission District 9,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having considered this matter at a public hearing, co-designates SW 180th Street the intersection of SW 137th Avenue as “Serena Lakes Blvd.”

Section 2. Directs the Clerk of the Board to transmit a certified copy of this resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Chairman Dennis C. Moss. It was offered by Commissioner Jose “Pepe” Diaz , who moved its adoption. The motion was seconded by Commissioner Dorrin D. Rolle and upon being put to a vote, the vote was as follows:
