

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE AUGUST 22, 2009 “BACK-TO-SCHOOL BOOK BAG GIVEAWAY” SPONSORED BY DADE COMMUNITY FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,310.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 2 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, Dade Community Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the August 22, 2009 “Back-to-School Book Bag Giveaway” in an amount not to exceed \$3,310.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the “Back-to-School Book Bag Giveaway” is a back-to-school book bag giveaway for students returning to school; and

WHEREAS, Dade Community Foundation, Inc. is a not-for-profit organization; and

WHEREAS, the “Back-to-School Book Bag Giveaway” is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$3,310.00 of the in-kind services shall be funded from the unspent balance of the District 2 FY 2008-09 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the



Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Dade Community Foundation, Inc., for their "Back-to-School Book Bag Giveaway" event held on August 22, 2009.

In-kind services have been requested in an amount not to exceed \$3,310 from the Miami-Dade Park and Recreation Department for the use of a medium show mobile, sound system and a 25 KW generator. This event will be funded from the District 2 FY 2008-09 in-kind reserve fund unspent balance.

In FY 2009-10, Dade Community Foundation, Inc. has received \$171,500 from the General Fund.
