

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE OCTOBER 10, 2009 "HOMECOMING EXTRAVAGANZA" SPONSORED BY MIAMI NORTHSIDE OPTIMIST CLUB, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,325.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 2 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, Miami Northside Optimist Club, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the October 10, 2009 "Homecoming Extravaganza" in an amount not to exceed \$1,325.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of the "Homecoming Extravaganza" is to celebrate the years of service that Northside Optimist Club has provided to the community; and

WHEREAS, Miami Northside Optimist Club, Inc. is a not-for-profit organization; and

WHEREAS, the "Homecoming Extravaganza" is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,325.00 of the in-kind services shall be funded from the unspent balance of the District 2 FY 2008-09 In-kind Reserve Fund,



I need the estimates for the following events:

- Northside Optimist Club_ 10/10/09 (Dis2) Showmobile small 12 hours 7AM to 7PM = \$1,325.00
- Spring River Festival We have never received any paperwork regarding the particulars of the 2010 event, if they are looking at the same date and equipment they used this year, you are looking at the third weekend in April 16-18, 2010, and use of the medium showmobile. For three 12 hour days = \$3,185.00
- Autism Speaks Based on last year's timetable, we have not seen this years set up and pick up time schedule. The large Showmobile and a 250 seat bleacher would be delivered on Saturday February 20, 2010 at 1PM, the actual event would be on Sunday February 21, 2010 from 8AM to 1PM with a pick up time of 2PM. The cost for these aforementioned two items would be \$3,616.00. In reviewing last years paper work they requested a large sound system and a Sound Technician too, I will verify with the event organizer tomorrow the actual delivery, and pick up times, along with what equipment is requested and adjust the aforementioned cost estimated if necessary.

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Miami Northside Optimist Club, Inc., for their "Homecoming Extravaganza" event held on October 10, 2009.

In-kind services have been requested in an amount not to exceed \$1,325 from the Miami-Dade Park and Recreation Department for the use of a small showmobile. This event will be funded from the District 2 FY 2008-09 in-kind reserve fund unspent balance.

In FY 2009-10, Miami Northside Optimist Club, Inc. has received \$14,000 from the General Fund.
