

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE NOVEMBER 6-8, 2009 "MIAMI MAN TRIATHLON" SPONSORED BY R.C. SOLUTIONS, CORP., A FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,230.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 4 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, R.C. Solutions, Corp. has requested in-kind services from the Miami-Dade Park and Recreation Department for the November 6-8, 2009 "Miami Man Triathlon" in an amount not to exceed \$1,230.00 (see attached Fee Waiver/In-kind Service Application); and

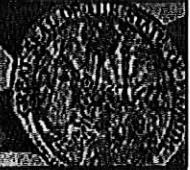

Subject: District Specific In-Kind Reserve Request Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by R.C. Solutions Corp, a-for-profit organization, for their "Multi-Race Miami Man Triathlon" held on November 6-8, 2009.

In-kind services have been requested in an amount not to exceed \$1,230 from the Miami-Dade Park and Recreation Department for the use of a 24'X40' stage. This event will be funded from the District 4 FY 2008-09 in-kind reserve fund unspent balance.

In FY 2009-10, R.C. Solutions Corp. has received no county funding for this event.
