



RESOLUTION AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE FEBRUARY 26, 2010 “CARNAVAL MIAMI 8K RUN” SPONSORED BY THE KIWANIS OF LITTLE HAVANA FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$1,225.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 4 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, the Kiwanis of Little Havana Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the February 26, 2010 “Carnaval Miami 8K Run” in an amount not to exceed \$1,225.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the “Carnaval Miami 8K Run” is a fundraiser to benefit community projects and programs overseen by the Kiwanis of Little Havana Foundation; and

WHEREAS, the Kiwanis of Little Havana Foundation, Inc. is a not-for-profit organization; and

WHEREAS, the “Carnaval Miami 8K Run” is a small event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$1,225.00 of the fee waiver shall be funded from the unspent balance of the District 4 FY 2008-09 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board authorizes a fee waiver from the Miami-Dade Park and Recreation Department for the February 26, 2010 “Carnaval Miami 8K Run” in an amount not to exceed \$1,225.00 to be funded from the unspent

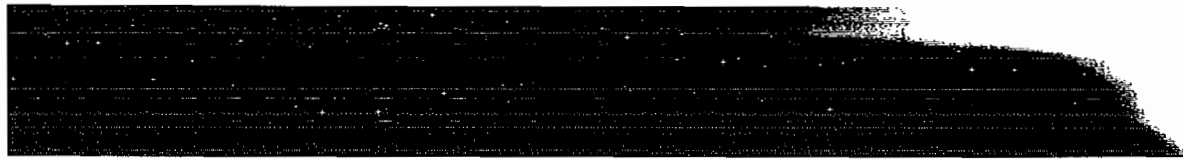

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district in-kind reserve balance allows for funding of this request.

Background

A waiver for in-kind services is being requested by a not-for-profit organization, the Kiwanis of Little Havana Foundation, Inc., for their "Carnaval Miami 8K Run" scheduled for February 26, 2010.
