



RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE DECEMBER 20, 2009 "ANNUAL HOLIDAY PARTY" SPONSORED BY DODGE CITY PICNICS, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,191.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 8 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, Dodge City Picnics, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the December 20, 2009 "Annual Holiday Party" in an amount not to exceed \$4,191.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "Annual Holiday Party" is a free event for all children and their families which celebrates the holidays; and

WHEREAS, Dodge City Picnics, Inc. is a not-for-profit organization; and

WHEREAS, the "Annual Holiday Party" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$4,191.00 of the in-kind services shall be funded from the unspent balance of the District 8 FY 2008-09 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the December 20, 2009 "Annual Holiday Party" in an amount not to exceed \$4,191.00 to be funded from the unspent balance of the District 8 FY 2008-09 In-kind Reserve Fund.



Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background
