Subject: Ratification of Contract Amendments for Eleven Sites and Termination for Convenience of Contracts with Four Vendors Within Contract No. 6869-0/14: Landscaping and Lawn Maintenance Services for Miami-Dade Public Housing Agency

**RECOMMENDATION**

It is recommended that the Board of County Commissioners approve the ratification of contract amendments for eleven of twenty-three sites (120, 130, 160, 170, 180, 210, 260, 280, 291, 320, and 340) awarded within Contract No. 6869-0/14: Landscaping and Lawn Maintenance Services for the Miami-Dade Public Housing Agency (MDPHA). It is also recommended that the Board approve the ratification of the termination for convenience of contracts with four vendors. This action is necessary to correct errors made during the bid evaluation that resulted in inaccurate awards. The amendments include an extension of time to make each term consistent with the original award.

**FISCAL IMPACT**

The solicitation required the award of the contract to be made to the three lowest, priced, responsive, responsible vendors, designated as primary, secondary, or tertiary, on a site-by-site basis. Based on the corrections to the bid tabulation resulting in the original award recommendations presented to the Board, an additional \$24,546 is required.

**BACKGROUND**

On July 2, 2009, the Board of County Commissioners approved a recommendation to award the referenced contract for landscaping services for 23 MDPHA sites. Thirty-nine bids were received in response to the solicitation. The bids were tallied and evaluated to identify primary, secondary and tertiary awardees. The resulting recommendation to award was posted with the Clerk of the Board on May 21, 2009. No protests were received. The Budget, Planning and Sustainability Committee forwarded the award recommendation to the Board on June 9, 2009 with a favorable recommendation. The Board awarded the contract on July 2, 2009.

On October 22, 2009, Statewide Maintenance/Striping, Inc (Statewide), the primary vendor identified for award of three sites (170, 240 and 340) advised the County it would withdraw from the contract because of its inability to provide the required services. Statewide representatives visited each site prior to submitting a bid. Following the award, the company advised that they misunderstood the scope of services required and, as such, could not continue to provide service at the price they bid. This action prompted the Department of Procurement Management (DPM) to identify the secondary vendor for these sites in order to provide continuity of services. This review resulted in a finding that the secondary vendor awarded at site 170 did not offer prices for all items and should have been deemed non-responsive, and therefore should not have been recommended for award.

Immediately following the discovery of the error, two staff teams independently performed comprehensive audits of the entire bid file and tallies to verify the awards were accurate. In addition, the DPM Director requested that the Audit and Management Services Department conduct an independent audit. That audit has been completed, corrections have been made, and the accuracy of the resulting recommendations has been confirmed. These recommendations have been implemented through the contract amendments that are presented in this item for ratification. Staff moved forward with amending the contracts immediately in order to correct the errors and ensure uninterrupted service to those residents residing in the affected housing units.

The most damaging errors were caused by reliance on an inaccurate bid tally to formulate the award recommendation as well as misapplication of the vendors' preference pursuant to Section 3 of the U.S. Housing and Urban Development Act of 1968 (sites 320 and 340). The errors that caused the incorrect award of these sites are significant and have adversely affected the procurement process. This Administration has no tolerance for errors of this type. The DPM and MDPHA Directors are pursuing appropriate disciplinary actions in regard to this matter.

Appropriate quality control measures continue to be implemented for preventative actions and accountability. Immediate corrective actions have been taken to avoid any such instance in the future. Process checklists have been enhanced to ensure that each vendor's bid has been reviewed in detail for every aspect of responsiveness. Responsiveness reviews include confirmation that bids received contain all required information and signatures. The checklist review will also ensure the vendor has submitted all applicable affidavits and documents necessary to determine vendors are capable of delivering the goods and/or services required by the County. Training sessions with front line staff on software programs used to create bid tallies will be held. Staff will be required to document, and confer, on any modifications to a bid tally before they are made. Supervisory staff will conduct independent reviews of bid tallies to ensure accuracy in the bid evaluation process. Staff has been instructed to work from a single document on a shared drive, and will not use e-mail versions prior to finalizing tallies. Staff is conducting market research to ascertain the feasibility of purchasing auditing software that will allow for even more effective data analysis to ensure accuracy.

Staff sought advice from the County Attorney's Office (CAO) to identify the appropriate corrective action, consistent with legal requirements, to minimize exposure to the County. Consistent with CAO advice, all affected vendors were contacted in order to secure concurrence in the re-award of contracts for the eleven sites to the correct firms based on the accurate evaluation of the bids. Letters were sent to each vendor in this regard. Staff has confirmed that the vendors who receive the new awards have the capability to perform the services. DPM has also worked with MDPHA staff to confirm that the application of Section 3 requirements is accurate, and to notify the U.S. Department of Housing and Urban Development of a smooth transition to minimize disruption to operations. In addition, an updated guidance document will be provided to MDPHA staff responsible for reviewing application of U.S. Department of Housing and Urban Development Section 3 requirements.

The following table depicts the vendors that should have been recommended for award, and those who were incorrectly awarded. It is respectfully requested that the Board: a) approve the ratification of contract amendments for sites 120, 130, 160, 170, 180, 210, 260, 280, 291, 320 and 340 within Contract No. 6869-0/14: Landscaping and Lawn Maintenance Services, with an extension of time to make each term consistent with the original award b) approve the termination for convenience of the contracts issued in error to S & V Tree & Stump Grinding Services, Inc., and Kasdem Service, Inc. (vendors who will not receive awards as a result of, and agreed to, the contract amendments and c) approve the termination for convenience of the contracts issued to Carswell Property Maintenance, Inc., and McIntyre Maintenance, Inc. (vendors who will not receive awards as a result of, and did not agree to the contract amendments).


