

**RESOLUTION NO. R-259-10**

**RESOLUTION WAIVING TERM LIMITS FOR EIGHT MEMBERS OF VARIOUS COUNTY BOARDS AND REAPPOINTING EACH APPOINTEE TO ANOTHER TERM**

**WHEREAS**, the following individuals are currently serving on various County boards (“appointees”):

V.T. Williams, Housing Finance Authority;  
Regina Giles, Nuisance Abatement Board;  
Richard M. Horton, Board of Rules and Appeals;  
Robert J. Stobs, II, Construction Trades Qualifying Board, Division A;  
Robert J. Jensen, Cultural Affairs Council;  
Jay Sosna, Planning Advisory Board;  
Curtis Lawrence, Community Council 14;  
Carlos Naumann, Unsafe Structures Board; and

**WHEREAS**, the County Code imposes a term limit for each member of the above-referenced boards; and

**WHEREAS**, pursuant to section 2-11.38.2 of the Code of Miami-Dade County, Florida, the Commission may by resolution adopted by a two-thirds (2/3) vote of members present waive a term limit applicable to a member of a County board; and

**WHEREAS**, the Commission wishes to waive the applicable term limits and reappoint each appointee to another term,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that the term limits applicable to the following appointees are hereby waived, and each appointee is reappointed to another term:

V.T. Williams, Housing Finance Authority;  
Regina Giles, Nuisance Abatement Board;  
Richard M. Horton, Board of Rules and Appeals;  
Robert J. Stobs, II, Construction Trades Qualifying Board, Division A;  
Robert J. Jensen, Cultural Affairs Council;  
Jay Sosna, Planning Advisory Board;  
Curtis Lawrence, Community Council 14; and  
Carlos Naumann, Unsafe Structures Board.
