RESOLUTION DIRECTING COUNTY MAYOR OR COUNTY MAYOR'S DESIGNEE TO PREPARE A FINDING OF NECESSITY STUDY FOR EXPANSION OF NW 7TH AVENUE CORRIDOR COMMUNITY REDEVELOPMENT AREA TO INCLUDE THE GEOGRAPHICAL AREA DESCRIBED GENERALLY AS BOUNDED ON THE NORTH BY THE CITY OF MIAMI GARDENS, BOUNDED ON THE SOUTH BY THE CITY OF NORTH MIAMI, BOUNDED ON THE WEST BY THE WESTERNMOST PROPERTY LINES OF ALL THOSE PARCELS OF LAND THAT ABUT THE WESTERLY RIGHT-OF-WAY LINE OF NW 7TH AVENUE/STATE ROAD 441 AND BOUNDED ON THE EAST BY INTERSTATE 95

WHEREAS, pursuant to Chapter 163, Florida Statutes (the "Act"), a Finding of Necessity study must be prepared in order to initiate the redevelopment process for areas believed to be slum and blighted; and

WHEREAS, the Act confers all redevelopment powers upon counties with home rule charters and authorizes such counties to delegate the exercise of such powers within the boundaries of a municipality to the governing body of such municipality; and

WHEREAS, the Board of County Commissioners of Miami-Dade County, Florida (the "Board") desires to authorize the County Mayor or the County Mayor's designee to select a consultant to prepare a Finding of Necessity study for an area of expansion for the NW $7^{\text {th }}$ Avenue Corridor Community Redevelopment Agency ("CRA") in accordance with the provisions of the Act; and

WHEREAS, on October 21, 2009, the Board of Commissioners of the CRA voted unanimously in support of conducting a Finding of Necessity study for the expansion of the CRA's boundaries; and

WHEREAS, the Board, desires to provide a mechanism for reimbursement of such expenses for the study from the Unincorporated Municipal Service Area non-departmental allocation, with possible reimbursement from funds on deposit in the community redevelopment trust fund pertaining to the NW $7^{\text {th }}$ Avenue Community Redevelopment Agency (the "Fund"), if available,

## NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA:

Section 1. The matters contained in the foregoing recitals are incorporated in this resolution by reference.

Section 2. The Board hereby directs the County Mayor or the County Mayor's designee to prepare a Finding of Necessity study for creation of an expansion of the NW $7^{\text {th }}$ Avenue community redevelopment area to include the geographical area described generally as bounded on the north by the City of Miami Gardens, bounded on the south by the City of North Miami, bounded on the west by the westernmost property lines of all those parcels of land that abut the westerly right-of-way line of N.W. $7^{\text {th }}$ Avenue/State Road 441 and bounded on the east by Interstate 95 .

Section 3. The Board hereby finds that the source of funding for payment of such consulting fees shall be the Unincorporated Municipal Service Area non-departmental allocation, with possible reimbursement from funds on deposit in the Fund, if available.
