

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE FEBRUARY 20-21, 2010 “CHRIST THE KING COMMUNITY INTERNATIONAL FESTIVAL AND CARNIVAL” SPONSORED BY ARCHDIOCESE OF MIAMI, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$4,000.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 11 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, the Archdiocese of Miami, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the February 20-21, 2010 “Christ the King Community International Festival and Carnival” in an amount not to exceed \$4,000.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the purpose of this event is to, among other things, promote unity in Southwest Miami-Dade County, promote the arts and culture of Haitian and Caribbean Americans and contribute to the Haitian Relief Project; and

WHEREAS, the Archdiocese of Miami, Inc. is a not-for-profit organization; and

WHEREAS, this event is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$4,000.00 of the in-kind services shall be funded from the unspent balance of the District 11 FY 2008-09 In-kind Reserve Fund,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board retroactively authorizes in-kind services from the Miami-Dade Park and Recreation Department for the February 20-21, 2010 “Christ the King Community International Festival and Carnival” in an

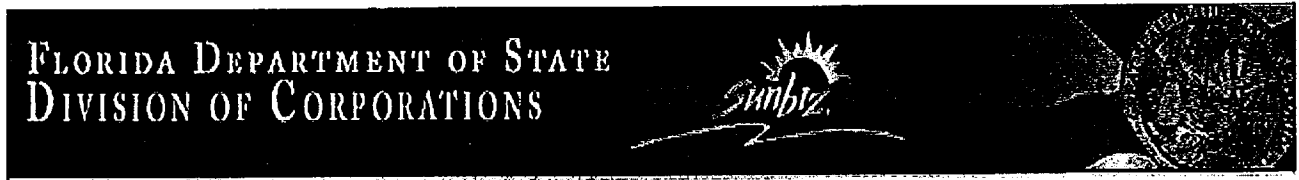

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background
