

RESOLUTION APPROVING THE CITY OF MIAMI'S  
RENAMING OF SE 1<sup>ST</sup> AVENUE FROM SE 8<sup>TH</sup> STREET TO SE  
12<sup>TH</sup> STREET AS "BRICKELL PLAZA"

**WHEREAS**, on February 9, 2006, the City Commission of the City of Miami adopted Ordinance No. 12755, renaming SE 1<sup>st</sup> Avenue from SE 8<sup>th</sup> Street to SE 12<sup>th</sup> Street as Brickell Plaza, a copy of which is attached and incorporated by reference; and

**WHEREAS**, SE 1<sup>st</sup> Avenue from SE 8<sup>th</sup> Street to SE 12<sup>th</sup> Street is a city street located within the boundaries of the City of Miami; and

**WHEREAS**, the City of Miami wants the County to install signage indicating this City street renaming on County street signs and traffic signal masts arms; and

**WHEREAS**, this renaming is located in County Commission District 7,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

Section 1. Approves the City of Miami's renaming of SE 1<sup>st</sup> Avenue from SE 8<sup>th</sup> Street to SE 12<sup>th</sup> Street in the City of Miami as "Brickell Plaza."

Section 2. Directs the Clerk of the Board to send certified copies of this Resolution to the Miami City Commission, the City Manager of the City of Miami, the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.
