Recommendation

The attached Contract Award Recommendation for the PTP Internally Illuminated Street Name Sign (Project – CICC 7040-0/07 RPQ No. 20090364), in the amount of \$319,610.40, between A. Bernal Services Corp. and Miami-Dade County has been prepared by the Public Works Department (PWD) and is recommended for approval. Proceeds from the Charter County Transit System Sales Surtax (the Surtax) will be used to fund this project, therefore, approval by the Board of County Commissioners (BCC) and Citizens' Independent Transportation Trust (CITT) is required.

Scope

The work to be performed under the life of this contract includes illuminated street name signs installation at various locations within Miami-Dade County.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$319,610.40 and will be funded from the Surtax. The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. Specific funding for traffic signs is included under Traffic Signals and Signs Operations in the PTP Countywide Neighborhood Improvements. The base contract amount is \$278,670.00, but the total allocated amount is \$319,610.40, which is inclusive of the contingency and dedicated allowances.

Delegation of Authority

No additional authority is being requested within the body of this contract.

Track Record/Monitor

A. Bernal Services Corp. is currently performing work for PWD at a satisfactory level as reported by the Project Manager. PWD has reviewed the Office of Capital Improvements (OCI) database and found one (1) awarded construction contract from PWD. The referenced database lists no contractor performance evaluation since the aforementioned contract is still on-going. The Department of Small Business Development's (SBD) History of Violation's report lists no violations for this contractor.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. Throughout all PTP projects, the responsible staff person in PWD will be the PTP Coordinator, Mr. Frank Aira, P.E. Following completion of the award process, the project will be assigned to Mr. Oscar Rubio, Project Manager, for day to day responsibilities.

According to the Florida Department of State, Division of Corporations, A. Bernal Services Corp., Company Principals are: Isabel Bernal, Armando Bernal and Wilfredo Gonzalez the Company's address is listed as: 725 SE 9 Court, Hialeah, Florida 33010.

Background

In an effort to carry on the success of the PTP Neighborhood Improvements initiative, PWD continues to take advantage of various contracting mechanisms such as the subject Miscellaneous Construction Contracting (MCC) process available under OCI contract CICC 7040-0/07. Through this process, PWD forwards the Request for Price Quotation (RPQ), by way of facsimile transmission, to a pool of pre-qualified Community Small Business Enterprise (CSBE) contractors for the subject trade. Additionally, PWD advertises the project in the Daily Business Review and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. The project award evaluation is based upon the lowest sum bid submitted by the responsive, responsible bidder for the project.

PWD staff determined that the scope of work for this project qualified for a CSBE set-aside (Levels I, II, and III) designation. Therefore, on December 22, 2009, PWD forwarded an RPQ for the PTP Internally Illuminated Street Name Sign Installation Contract, utilizing the OCI contract CICC 7040-0/07, to a list of 44 pre-qualified firms. A total of seven (7) firms purchased contract documents and five (5) firms proffered a bid. On January 29, 2010, A. Bernal Services Corp. proffered the lowest responsive, responsible base bid of \$278,670.00, 21% below the County's cost estimate; the second lowest bidder, Statewide Electrical Services, Inc., proffered a base bid of \$289,916.30, 4% over the lowest bidder; the third lowest bidder, R & D Electric, Inc., proffered a base bid of \$296,110.00, 6% over the second lowest bidder. As a result, on February 10, 2010, PWD issued a recommendation of award for RPQ No. 20090364 to A. Bernal Services Corp., with the stipulation that approval of this project must be obtained from the BCC and the CITT due to guidelines associated with the funding source.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, tools and equipments required to provide the installation of internally illuminated street name signs at various intersections in Miami-Dade County. The work includes the removal of existing overhead signs, relocation of existing signal heads and tree trimming in conflict with the proposed scope of work as directed by the Engineer. The Contractor shall keep the Engineer informed at all times of his work schedule, in order for the project to be inspected during all phases of installation, including wire splicing, installation of conductors and any work involving the electrical connections at the controller cabinet.






