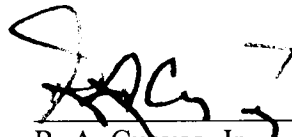

RESOLUTION WAIVING REQUIREMENTS OF
ADMINISTRATIVE ORDER 3-38 FOR SECURING
SPONSORSHIPS AND PURCHASING GOODS AND
SERVICES FOR HOSTING THE 6TH ANNUAL JOE A.
MARTINEZ HEALTH AND SAFETY EXPO, JUNE 26, 2010

WHEREAS, Administrative Order 3-38 was established pursuant to Section 2-8.1 of the Code of Miami-Dade County to establish processes and procedures for County procurements; and

WHEREAS, the 6th Annual Joe A. Martinez Health & Safety Expo is currently scheduled for June 26, 2010 and is an important free Miami-Dade County event for people of all ages and areas of Miami-Dade County to educate themselves on personal wellness and healthier living; and

WHEREAS, it is in the best interests of the County to hold this event on June 26, 2010 and to continue to have this event in the future; and

WHEREAS, the Office of County Commissioner Joe A. Martinez, District 11, of the Miami-Dade Board of County Commissioners, will host the 6th Annual Joe A. Martinez Health & Safety Expo on June 26, 2010 and purchase goods and services to do so; and

WHEREAS, the Office of County Commissioner Joe A. Martinez, District 11, of the Miami-Dade Board of County Commissioners will secure sponsors to assist in defraying the costs of hosting this free County health fair; and

WHEREAS, the acquisition of sponsorships and the purchase of goods and services to host the 6th Annual Joe A. Martinez Health & Safety Expo on June 26, 2010 are below the threshold amount requiring formal sealed bids set forth Section 2-8.1 of the Code of Miami-Dade County,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that the requirements of administrative orders including Administrative Order 3-38 and any and all applicable Miami-Dade County Department of Procurement Guidelines are waived for obtaining sponsorships and purchasing goods and services to host the 6th Annual Joe A. Martinez Health & Safety Expo on June 26, 2010.

The Prime Sponsor of the foregoing resolution is Commissioner Joe A. Martinez. It was offered by Commissioner **Dorrin D. Rolle**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:
