Subject: Contract Award Recommendation in the Amount of \$1,155,000.00 between Solution Construction, Inc. and Miami-Dade County for the People's Transportation Plan (PTP) Project Entitled Intersection Improvement Contract (**Project – CICC 7360-0/08 Request for Price Quotation (RPQ) No. 20090314**) and Authorizing the Use of Charter County Transit Surtax Funds

Recommendation

The attached Contract Award Recommendation for the Intersection Improvement Contract (Project – CICC 7360-0/08 RPQ No. 20090314), in the amount of \$1,155,000.00, between Solution Construction, Inc. and Miami-Dade County has been prepared by the Public Works Department (PWD) and is recommended for approval. Proceeds from the Charter County Transit System Sales Surtax (the Surtax) will be used to fund this project, therefore, approval by the Board of County Commissioners (BCC) and Citizens' Independent Transportation Trust (CITT) is required.

Scope

The work to be performed under the life of this contract includes intersection improvements at various locations within Miami-Dade County.

Fiscal Impact/Funding Source

The fiscal impact will be approximately \$1,155,000.00 and will be funded from the Surtax. The proposed improvements qualify under the allowable work categories included in the PTP Neighborhood Improvements Section. Specific funding for this project will be allocated from the respective Commission District PTP yearly allocations. This is a work order based contract with a base contract amount of \$1,000,000.00. The total recommended award amount is \$1,155,000.00, which is inclusive of the contingency and dedicated allowances.

Delegation of Authority

No additional authority is being requested within the body of this contract.

Track Record/Monitor

Solution Construction, Inc. is currently performing work for PWD at a satisfactory level as reported by the Project Manager. PWD has reviewed the Office of Capital Improvements (OCI) database and found 16 awarded construction contracts and are listed as follows: one (1) from the Housing Department (HD), one (1) from the General Services Administration Department (GSA), two (2) from the Water and Sewer Department (WASD), ten (10) from the Parks and Recreation Department (PRD) and two (2) from PWD. The referenced database also lists a total of 14 contractor performance evaluations (several contracts having two (2) evaluations on file, an interim and a project closeout) with an overall performance rating of satisfactory performance (3.6), out of a possible superior performance (4.0) rating.

The Department of Small Business Development's (SBD) History of Violation's report lists one (1) open violation for \$175,935.10 due to the Utilization of Non Certified Small Business Enterprise (CSBE) Firm for CSBE/Set Aside Work.

On February 17, 2010, PWD sent the Contractor a letter advising them to contact SBD and that they must obtain SBD's approval for a make-up plan in order to be eligible for an award recommendation. SBD has notified PWD that, in addition to the 10% overall goal established for the contract, a make-up plan providing for an additional \$88,000.00 (8%) of work for a CSBE, has been submitted and approved. In accordance with Section 10-33.02 of the Miami-Dade County Code, the Contractor is being given the opportunity to make up their outstanding goal deficit and should they fail to comply with any of the material terms of this Make-up plan, without good cause, they shall be subject to an automatic suspension from bidding and/or otherwise participating on County contracts as a prime or subcontractor for a six (6) month period.

Following PWD's standard operating procedures, after award of this contract, a pre-construction meeting will be scheduled. Throughout all PTP projects, the responsible staff person in PWD will be the PTP Coordinator, Mr. Frank Aira, P.E. Following completion of the award process, the project will be assigned to Mr. Joaquin Rabassa, P.E., Project Coordinator, for day to day responsibilities.

According to the Florida Department of State, Division of Corporations, Solution Construction, Inc., Company Principals are: Andres Correa and Lain Ruiz and the Company's address is listed as: 7955 NW 12 Street, Suite 425, Doral, Florida 33126.

Background

In an effort to carry on the success of the PTP Neighborhood Improvements initiative, PWD continues to take advantage of various contracting mechanisms such as the subject Miscellaneous Construction Contracting (MCC) process available under OCI contract CICC 7360-0/08. Through this process, PWD forwards the Request for Proposal Quotation (RPQ), by way of facsimile transmission, to a pool of firms that have registered with OCI for the subject trade. Additionally, PWD advertises the project in the Daily Business Review and all solicitations are available on-line through the Miami-Dade County portal under the "Procurement Solicitations" link. Interested contractors prepare their bids according to the Job Order Contracting (JOC) process, whereby the County establishes unit prices for the pay items in accordance with industry averages. The contractors submit their bid as an overall percentage factor of the pricing established by the County. The project award evaluation is based upon the lowest percentage submitted by the responsive, responsible bidder for the project.

PWD staff submitted the referenced project to the SBD Review Committee. The Review Committee met on October 28, 2009, reviewed RPQ No. 20090314 and recommended a 10% overall CSBE subcontractor goal based on the project's scope of work and cost estimate of \$1,000,000.00. Therefore, on December 3, 2009, PWD forwarded an RPQ for the Intersection Improvement Contract, utilizing the OCI contract CICC 7360-0/08, to a list of 49 pre-registered firms. A total of 24 firms purchased contract documents and 19 firms proffered a bid.

PWD staff met with the County Attorney's Office, in regards to Florida Blacktop, Inc.'s bid, due to several irregularities on the bid form. The firm materially deviated from the bid form and did not allow the County to make a fair comparison of the bid prices. The alteration of the bid form and the failure to bid a factor as required is material to the evaluation criteria. As such, the bid was found to be "not-responsive."

The lowest responsive, responsible bidders, Solution Construction, Inc. and Leon's Engineering Corp., proffered matching percentage factors of 0.88%. Therefore, on February 3, 2010, both firms submitted a "Best and Final" bid and as a result, Solution Construction, Inc., proffered the lowest responsive, responsible base bid of 0.86 percentage factor, 14% below the County's cost estimate;

the second lowest bidder, Leon's Engineering Corp., proffered a base bid of 0.88 percentage factor, 2% over the lowest bidder; the third lowest bidders, Budget Construction Co., Inc., H & J Asphalt, Inc., Morlic Engineering Corp., and Quality Paving Corp. proffered a base bid of 0.89 percentage factor, 1% over the second lowest bidder.

Solution Construction, Inc., is a certified CSBE firm that may perform up to fifty percent (50%) of a CSBE subcontractor goal with its own forces. The remaining subcontractor goal work listed on the Schedule of Intent (SOI) Affidavit shall be performed by Rumbo Paving & Drainage, Inc., also a certified CSBE firm, to perform pavement marking work to meet the remaining goal of 5% CSBE participation. In addition to the required 10% CSBE participation, SBD approved Solution Construction's make-up plan to include work to be performed by Lines Unlimited, Inc., a certified CSBE firm, to perform striping work in the amount of \$88,000.00 (8%) towards the CSBE goal deficit make-up amount.

As a result, on March 2, 2010, PWD issued a recommendation of award for RPQ No. 20090314 to Solution Construction Inc., with the stipulation that approval of this project must be obtained from the BCC and the CITT due to guidelines associated with the funding source.

The work to be accomplished for this project consists of, but is not limited to, furnishing all supervision, labor, required materials, equipment and tools to perform all operations necessary for intersection improvements. This work includes construction of asphaltic concrete road base and surface, pavement removal, pavement milling and markings, signage, drainage, sidewalks, concrete curbs and gutter and traffic calming devices.

Dear Mr. Correa:

The Department of Small Business Development (SBD) is in receipt of Solution Construction, Inc.'s (Solution) plans dated February 18, 2010, requesting to make-up a portion of your goal deficit of \$175,935.10 on project nos. 20090313 and 20090314.

The total base plus contingency amount for each of the referenced projects is \$1,100,000.00. Both projects have a 10% CSBE goal. Solution is meeting 5% on both projects and has committed to utilizing Rumbo Paving and Drainage for 5% on both projects. Solution's partial make-up plan included a Schedule of Intent Affidavit (SOI) listing Lines Unlimited, Inc. (Lines Unlimited) to perform striping work valued at \$99,000 or 9% on project no. 20090313 and \$88,000 or 8% on project no. 20090314.

The Department of Public Works (PW) has confirmed that there is sufficient striping work available on both projects for Lines Unlimited to meet the CSBE participation proposed. Based on this information, Solution Construction Inc.'s make-up plans of \$99,000 on Project No. 20090313 and \$88,000 on Project No. 20090314 are hereby approved, for a total make-up of \$187,000. Counting previously approved make-up plans of \$45,500 (Project 20090025) and \$57,025.76 (Project CGJPA 2008.03), if achieved the remaining make-up balance will be \$0.00 (\$175,935.10 - \$45,000 - \$57,025.76 - \$187,000).

Pursuant to the Code, the certification of all firms being utilized to meet a CSBE measure must be valid at time of bid submittal, bid award and throughout the term of the contract. Subcontracting CSBE's must perform a commercially useful function in the supply of services required for the fulfillment of the contract and cannot subcontract work further. In the event that this CSBE is not able to perform the scopes of work intended to meet the goal and make-up, Solution must take immediate action to locate a substitute to perform the work and request approval from SBD. In order to review the subject project, a Monthly Utilization Report (MUR) is required to be submitted by the tenth of each month for the projects for the duration of the projects. The form should be completed indicating the current utilization of all firms listed on the SOI's.

Please, note that on June 2, 2009, the Miami-Dade Board of County Commissioners adopted Ordinance 09-41 amending the Code to require a contractor who fails to meet an established

CSBE goal to submit a CSBE Make-up Plan for approval by the SBD Director. A Make-up Plan and a corresponding Schedule of Intent Affidavit must be submitted as part of any bid or proposal submitted for future contracts at the time of bid or proposal submittal. Failure to include the required SOI with bids or proposals for any future contracts shall result in the submittal being deemed non-responsive.

The amendment also included the addition of the following sanctions for failing to satisfy an approved CSBE make-up plan:

- Automatic suspension from bidding and/or otherwise participating on County Contracts as a prime or subcontractor for a (6) six month period for a contractor failing to comply with any of the material terms of an approved make-up plan without good cause.
- Automatic suspension from bidding and/or otherwise participating on County Contracts as a prime or subcontractor for a one (1) one year period for a contractor failing to comply with any of the material terms of a second make-up plan without good cause.
- Automatic referral to the Debarment Committee for failing to contractor with any of the material terms of a third make-up plan, with good cause. After serving a debarment for failure to satisfy a make-up plan for no good cause, the subject firms shall be ineligible for bidding on County Contracts with a measures for on (1) additional year unless the County Manager determines that an emergency exists justifying such participation, and the Board of County Commissioners approves such decision.



The Miami-Dade County Department of Small Business Development (SBD) is responsible for monitoring awarded contracts for compliance with the following programs: Community Small Business Enterprise (CSBE), Community Business Enterprise (CBE), and the Small Business Enterprise (SBE). Pursuant to the referenced programs, contractors that fail to achieve the CSBE, CBE or SBE measures on contracts must make-up any work on future County work. Further, the aforementioned programs require make-ups be made as a condition of any new award. Summary

This resolution recommends a contract award to Solution Construction, Inc. for intersection improvements (Project CICC 7360-0/08 RPQ No. 20090314) at various locations within Miami-Dade County totaling \$1,155,000.

Background and Relevant Information

Solution Construction has one (1) open violation for utilization of non-certified CSBE Firm/Set Aside Work. A Notice of Violation was issued on Project No. 46440, Rock Ridge Park Site Development. They were required to do a CSBE make-up for \$175,935.10.

According to Small Business Development (SBD) staff, the following are approved make-up plans to cure the above mentioned violation: (1) Project No. CGJPA 2008.03 for a dollar value of **\$57,025.76 (contract awarded)**; (2) make-up plan for **Project No. 20090313** totaling \$99,000 (pending approval); and (3) make-up plan for **Project No. 20090314** totaling \$88,000 (pending approval).

Approved Make-up Plans

Solution has submitted and received SBD approval on the following five (5) make-up plans:

1. 8/13/08, Project No. W70259 valued a \$175,935.10. This plan was voided because the project was to Miami Skyline.
2. 8/24/09, Project No. 20090025 (7360) for \$45,500. This plan was voided because the Public Works Department removed the scope of work to be performed by the CSBE meeting the make-up plan.
3. **11/23/09, Project No. CGJPA 2008.03 valued \$57,025.76. Project awarded to Solutions, no payment information in oracle at this time.**
4. **2/18/10, Project No. 20090313 valued \$99,000. Award Pending**
5. **2/18/10, Project No. 20090314 valued \$88,000. Award Pending**

According to SBD staff, if Solution completes Plan Nos. 3-5, the make-up will be closed.

Legislative History

Currently under § 10-33.02 of the Code of Miami-Dade County, a contractor who is awarded a County contract, determined to be appropriate for CSBE participation, is required to fulfill CSBE goals as established by the County. Failure to achieve the CSBE participation goals may subject the contractor to a variety of sanctions including suspension, work stoppage, termination/cancellation of the contract, and debarment.

In addition to any other sanction for failure to fulfill the CSBE measure requirements, the contractor's eligibility to receive any future county contracts may be conditioned upon the contractor making up the deficit in CSBE participation in such future contracts by having CSBE(s) perform equal to double the dollar value of the deficiency in the CSBE measure in the prior contract.

On June 2, 2009, the BCC, through Ordinance 09-41¹, approved additional parameters for future contracts and penalties for failing to meet an established CSBE goal. Also, failure to include the required Schedule of Intent Affidavit for any future contracts will result in the submittal of a bid or a proposal being deemed non-responsive.

- At the June 2, 2009, BCC meeting, concerns were raised that firms could continue to violate the CSBE policies and accept another County contract if they agree to an approved make-up plan.

¹ Contract language will provide that in order to be eligible for future county contracts, a contractor who fails to meet an established CSBE goal will submit a CSBE Make-up Plan for the approval of the Director. A Make-up Plan and a corresponding Schedule of Intent Affidavit must be submitted as part of any bid or proposal submitted for future contracts at the time of bid or proposal submittal.

Any contractor subject to an approved Make-up Plan that fails to comply with any of the material terms of that Make-up plan, without good cause, will be subject to an automatic suspension from bidding and/or otherwise participating on County contracts as a prime or subcontractor for a six (6) month period. A contractor that fails to comply with any of the material terms of a second Make-up plan, without good cause, will be subject to an automatic suspension from bidding and/or otherwise participating on County contracts as a prime or subcontractor for a one (1) year period.
