RESOLUTION NO. R-525-10

RESOLUTION ESTABLISHING A POLICY THAT PERSONS OR ENTITIES RECEIVING COUNTY FUNDING DISPLAY THE COUNTY LOGO OR OTHERWISE APPROPRIATELY RECOGNIZE THE COUNTY IN MATERIALS AND SIGNS RELATED TO THE PROJECT AND DIRECTING THE COUNTY MAYOR OR MAYOR'S DESIGNEE TO INCLUDE A PROVISION SO REQUIRING IN GRANT CONTRACTS

WHEREAS, it benefits the public to raise awareness of the diverse and important projects and programs that Miami-Dade County supports; and

WHEREAS, for example, Miami-Dade County supports with grants such deserving groups as Boys and Girls Clubs of Miami, Inc., Big Brothers and Sisters of Greater Miami, Inc., Camillus House, Inc., Coalition of Florida Farmworkers, Inc., Columbian American Service Association, Inc., Dominican-American National Foundation, Inc., Haitian Cultural Arts Alliance, Inc., Jewish Community Services of South Florida, Inc., Legal Services of Greater Miami, Inc., Little Havana Activities and Nutrition Centers of Dade County, Inc., Liberty City Optimist Club of Florida, Inc., Miami Book Fair International, Switchboard of Miami, Inc., Mailman Center for Child Development, and Mujeres Unidas En Justicia Educacion y Reforma, Inc.; and

WHEREAS, it is fitting and proper that a project or program receiving support from the Miami-Dade County acknowledge such support,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that it is the policy of this Board that persons and entities that receive funding or grants from Miami-Dade County acknowledge the County's support by including the County logo on materials or signage pertaining to the project. In this regard, the County Mayor or Mayor's designee is instructed to

include language requiring such recognition of the County's contribution in the contracts or agreements providing the funding or grant. The Board recognizes that such recognition may take different forms in different contexts and approves an approach that allows flexibility in such provisions.

The Prime Sponsor of the foregoing resolution is Commissioner Barbara J. Jordan. It was offered by Commissioner **Dorrin D. Rolle**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:
