Subject: Resolution Authorizing Award of Competitive Contracts

Agenda Item No. 8(O)(1)(B)

Resolution No. R-421-10

This item, listed as Agenda Item 3D on the March 9, 2010 Budget, Planning and Sustainability Committee meeting agenda, was bifurcated and amended as follows:

- The allocation for Miami-Dade Police was removed from Item 1.1 Emergency Management & Homeland Security Professional Services (Prequalification).
- On page 2 of the Memorandum, the total requested allocation for Item 1.1 Emergency Management & Homeland Security Professional Services (Prequalification), is now \$3,750,000 for the initial five-year term, thereby changing the cumulative value of the contract to \$11,250,000.
- All OTRs for Item 1.1 Emergency Management & Homeland Security Professional Services must be presented individually to the Board for approval.

In addition, the item was amended to correct a scrivener's error on Item 1.1 Emergency Management & Homeland Security Professional Services (Prequalification):

- Funding source for the Transit Department should read Homeland Security Grant Program.

Recommendation

It is recommended that the Board of County Commissioners approve the attached award of competitive contracts, rejection of bids, and contract modifications with authority to exercise options-to-renew.

Contract amounts and department allocations represent the maximum spending authority based on past utilization. This action does not guarantee that the total contract amount/value will be expended by County departments and/or agencies.

Scope

The impact of the items in the accompanying Award of Competitive Contracts Package is countywide in nature.

Fiscal Impact/Funding Source

Funding will be expended only if departmental budgets can support the expenditures approved in their Resource Allocation Plan adopted annually by the Board.

Track Record/Monitor

There are no known performance issues with the vendors recommended for award in the Award of Competitive Contracts Package. Each department's contract manager is reflected in the Award of Competitive Contracts Package.

Delegated Authority

If this item is approved, the County Mayor or County Mayor's designee will have the authority to exercise, in their discretion, subsequent options-to-renew (OTR) and extend contracts for purchase of goods and services in accordance with the terms and conditions of the each contract.

Background

Section 1 AWARD OF COMPETITIVE BIDS

The contracts listed in this section are being recommended for award to the responsive, responsible bidder(s) who met the requirements of the respective solicitation.

Item 1.1: Emergency Management & Homeland Security Professional Services (Prequalification) is to award this contract for emergency management and homeland security professional services for various County departments. The amount being requested is **\$3,750,000**. If the County chooses to exercise the two, five-year OTR periods, the cumulative value will be **\$11,250,000**.

Section 2 REJECTED BIDS

A bid may be rejected when adverse conditions exist such as the proposal not conforming to the specifications and/or solicitation documents, insufficient financial resources, technical ability, physical capacity and/or skill of the vendor, unfair and unreasonable pricing, insufficient competition and for any other cause in the best interest of the County.

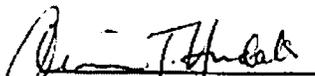
BACKGROUND

This contract establishes a pool of vendors that are pre-qualified to provide Emergency Management and Homeland Security Professional Services for the Emergency Management & Homeland Security, Miami-Dade Aviation, Miami-Dade Transit and Miami-Dade Police departments.

The vendor pool will provide the participating departments with access to a wide variety of services such as, training for compliance with National Standard Incident Command Systems, Department of Homeland Security and Federal Emergency Management Agency's training courses, disaster prevention planning services, and support in conducting emergency management mock exercises, drills and simulations. These services will enhance the County's ability to respond and react to emergency situations. In addition, the support provided will strengthen the effectiveness of public outreach and education initiatives, critical
