Plat Restrictions

- That the Streets and Avenue, as illustrated on the plat, together with all existing and future planting, trees, shrubbery and fire hydrants thereon, are hereby dedicated to the perpetual use of the public for proper purposes, reserving to the dedicators, their successors or assigns, the reversion or reversions thereof whenever discontinued by law.
- That individual wells shall not be permitted within this subdivision, except for swimming pools, sprinkler systems and/or air conditioners.
- That the use of septic tanks will not be permitted within this subdivision, unless approved for temporary use, in accordance with County and State regulations.
- That all new electric and communication lines, except transmission lines, within this subdivision, shall be installed underground.
- That the utility easement, depicted by dashed lines on the plat, is hereby reserved for the installation and maintenance of public utilities.

RESOLUTION NO. R-466-10

RESOLUTION APPROVING THE PLAT OF COMMUNITY HEALTH CENTER, LOCATED IN THE NORTHEAST 1/4 OF SECTION 22, TOWNSHIP 53 SOUTH, RANGE 41 EAST (BOUNDED ON THE NORTH BY NW 54 STREET, ON THE EAST BY APPROXIMATELY NW 21 AVENUE, ON THE SOUTH BY NW 52 STREET, AND ON THE WEST BY NW 22 AVENUE)

WHEREAS, Economic Opportunity Family Health Center, Inc., currently known as Jessie Trice Community Health Center, Inc., a Florida not-for-profit corporation, has this day presented to this Board a plat of certain lands lying in Miami-Dade County, Florida, said plat to be known as COMMUNITY HEALTH CENTER, the same being a replat of Block 4 and a portion of Lot 3, and Lots 4 through 9, Block 5, of "Olinda Villas", according to the plat thereof, as recorded in Plat Book 5, at Page 95, of the Public Records of Miami-Dade County, Florida, and that portion of right-of-way closed by Resolution R-439-02, all lying and being in the Northeast 1/4 of Section 22, Township 53 South, Range 41 East Miami-Dade County, Florida, and it appears that all requirements of law concerning said plat insofar as the authority of this Board is concerned have been complied with,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that said plat is hereby approved; that the dedication of the streets, alleys and other rights-of-way however designated or depicted on said plat is hereby accepted; that the Miami-Dade County Plat Restrictions as listed on said plat are approved and are to be enforced; that approval of the plat is not a waiver of any zoning regulations and that the requirements of the zoning existing on this land at the time this

resolution is approved shall be enforced whether or not the various parcels on this plat conform to those requirements; this approval is conditioned upon the proper execution of all documents required by the County Attorney's Office.

The foregoing resolution was offered by Commissioner **Audrey M. Edmonson**, who moved its adoption. The motion was seconded by Commissioner **Joe A. Martinez** and upon being put to a vote, the vote was as follows:
