

Subject: Resolution Authorizing the Execution of a Supplemental Joint Participation Agreement with the Florida Department of Transportation to Provide Additional State Funding for a Park and Ride Facility at the Florida Power & Light Site on SW 127<sup>th</sup> Avenue Near Kendall Drive in the Amount of \$379,900

**RECOMMENDATION**

It is recommended that the Board of County Commissioners (Board) authorize the execution of a Supplemental Joint Participation Agreement (SJPA) in substantially the form attached hereto with the Florida Department of Transportation (FDOT) to provide additional State funding in the amount of \$379,900 and add the additional eligible expenses for leasing, final design, Construction Engineering and Inspection (CEI) services and design services during construction of a Park and Ride facility at the Florida Power and Light (FP&L) site on SW 127<sup>th</sup> Avenue near Kendall Drive.

It is further recommended that the Board authorize the receipt and expenditure of funds as specified in the Agreement. An equal match of \$379,900 will be provided from proceeds from the Local Option Gas Tax (LOGT) and the Charter County Transit System Surtax (Surtax).

**SCOPE**

While this park and ride lot is physically located within Commission District 10, the impact of the project benefits the riding public, and is therefore, countywide.

**FISCAL IMPACT/FUNDING SOURCE**

The State's \$379,900 funding contribution would be matched equally by Miami-Dade County with \$379,900 from LOGT and Surtax funds.

**TRACK RECORD/MONITOR**

MDT has entered into numerous funding agreements with FDOT over the course of more than twenty-five (25) years. The project manager for this grant application is Patricia Barry, Administrative Officer 3, MDT Financial Services.

**DELEGATED AUTHORITY**

In accordance with Section 2-8.3 of the Miami-Dade County Code related to identifying delegation of Board authority, there are no authorities beyond that specified in the resolution which include authority for the Mayor or designee to execute the agreement, receive and these and any additional funds should they become available.

**BACKGROUND**

The State of Florida's Park and Ride Lot Program was initiated in 1982 to provide organized, safe parking for vehicles constantly congregating on roadsides. Initially, park and ride lots were constructed on publicly owned land such as rights of way, park lands and state owned land. Chapter 341 of the Florida Statutes (F.S.) provides for the purchase and/or leasing of private land for the construction of park and ride lots, the promotion of these lots, and the monitoring of their usage. This program is an

integral part of the commuter assistance program efforts to encourage the use of transit carpools, vanpools, and other high occupancy modes. It is essential in an effort to meet federal, state, regional and local goals for reducing single occupant vehicle travel.

The total estimated project cost is 2.759 million. On June 5, 2007, the Board approved an initial \$1,000,000 in FDOT Park and Ride Lot Program funds for land acquisition and construction through a Joint Participation Agreement (JPA) authorized by Resolution No. 677-07; this amount was equally matched by the County. This SJPA is a revised scope of the agreement, which includes leasing, final design and CEI services. The total funding received for this project to date is \$1,379,900. The remaining \$379,900 will be provided from LOGT and PTP funds.

The FDOT plan for Miami-Dade County was based on the demand for Park and Ride use in association with "kiss and ride", carpool, and local and premium bus service. The proposed Park and Ride lot, currently owned by FP&L consist of three different parcels totaling approximately 2.3 acres. MDT and FPL are negotiating a license/lease agreement for these three parcels. The license/lease agreement is being worked on in conjunction with FPL's proposed project (overhead transmission lines) from SW 57<sup>th</sup> Avenue to SW 38<sup>th</sup> Court along Ponce de Leon and encroaching into MDT right-of-way. This license/lease agreement will be presented to the Board for approval through a separate item.

This surface lot will provide parking for approximately 150 vehicles and is scheduled to be completed in the Spring of 2011. Routes 88 and 288 (Kendall KAT) currently serve this location. The planned Kendall Enhanced Bus (KEB) service is anticipated to replace the Kendall KAT with improved service; therefore, this park and ride lot will be important for the future support of the KEB project.

RESOLUTION AUTHORIZING EXECUTION OF A SUPPLEMENTAL JOINT PARTICIPATION AGREEMENT (SJPA) WITH THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) TO PROVIDE ADDITIONAL STATE FUNDING IN THE AMOUNT OF \$379,900 FOR A PARK AND RIDE FACILITY AT THE FLORIDA POWER & LIGHT SITE (FP&L) ON SW 127TH AVENUE NEAR KENDALL DRIVE; AUTHORIZING THE RECEIPT AND EXPENDITURE OF FUNDS AS SPECIFIED IN THE SJPA; AUTHORIZING RECEIPT AND EXPENDITURE OF ANY ADDITIONAL FUNDS SHOULD THEY BECOME AVAILABLE AS SPECIFIED IN THE SJPA; AND AUTHORIZING THE USE OF CHARTER COUNTY TRANSIT SYSTEM SURTAX FUNDS AS A MATCH FOR THE JOINT PARTICIPATION AGREEMENT (JPA) AND THE SJPA

**WHEREAS**, this Board desires to accomplish the purposes outlined in the accompanying memorandum, a copy of which is incorporated herein by reference; and

**WHEREAS**, the State of Florida is authorized to enter into agreements to provide State funding for transportation programs and projects,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA:**

Section 1. That this Board approves the agreement between Miami-Dade County and the Florida Department of Transportation, in substantially the form attached hereto and made a part hereof, in the amount of \$379,900 for leasing, final design, CEI services and design services during construction of a park and ride lot facility at the Florida Power & Light site on SW 127th Avenue near Kendall Drive.

Section 2. That this Board further authorizes the Mayor, Mayor's designee, or Miami-Dade Transit Director, to execute such contracts and agreements as are approved by the County Attorney's Office; to receive and expend funds in accordance with such aforementioned contracts and agreements; to receive and expend any additional funds should they become available; and to file and execute any additional agreements, revisions, or amendments as required to carry out the projects for and on behalf of Miami-Dade County, Florida.

Section 3. That the County staff is authorized to furnish such additional information as the FDOT may require in connection with the application for the improvement.

The foregoing resolution was offered by Commissioner **Dorrin D. Rolle**, who moved its adoption. The motion was seconded by Commissioner **Dennis C. Moss** and upon being put to a vote, the vote was as follows:

**1.00 Project Description:** The project description is amended to revise the scope of the agreement to include as eligible costs: leasing, final design, CEI services & design services during construction. In addition, additional Department Park and Ride Lot Program funding is provided for this facility to be located on SW 127th Avenue near Kendall Drive (SR 94). State Participation Rate is 50% of eligible project costs.

bringing the revised total cost of the project to \$ 2,759,800.00 .

Paragraph 4.00 of said Agreement is increased by \$379,900.00
