Subject: Recommendation to Reject All Proposals Received for Consulting Services for the
 County's Elevators, Escalators, and Related Equipment

RECOMMENDATION

It is recommended that the Board of County Commissioners approve the rejection of all proposals received in response to EPP-RFP 625, Consulting Services for the County's elevators, escalators, and related equipment for General Services Administration.

BACKGROUND

The referenced Request for Proposals (RFP) was advertised to establish contracts with elevator consultants to evaluate work and performance of the current elevator maintenance service providers. The RFP was solicited to establish contracts with two qualified vendors for: (i) Inspection and survey of equipment conditions, evaluation of on-going maintenance programs, provision of progressive and annual reports of findings, and; (ii) On-call code compliance inspection and reporting services for elevators, escalators, moving walkways and other related equipment.

It should be noted that professional, licensed County staff currently inspects all equipment for code compliance and witnesses periodic tests performed by maintenance service contractors at least once per year as required by law. This solicitation was requested by the Board to verify that the contractors were performing specified maintenance in accordance with County contractual requirements. Failure to award this solicitation will have no effect on the current safety levels of the equipment.

There has been a significant delay in bringing this recommendation for approval due to lengthy technical evaluations of the proposals submitted, price analyses, and negotiations. If the County inspects the entire elevator inventory, the overall contract cost to the County could be approximately \$2.9 million for the first year. This amount also includes the support services that would be required of the maintenance contractors to disassemble the elevator/escalator components to accommodate inspection. See Table 1 below for cost estimates:

Additionally, County staff would be required to oversee the contract. The above totals do not include the cost of on-call code compliance inspection and reporting services that are included in this Request for Proposals on an as-needed basis. In light of the costs associated with these services and the County's current budget situation, it is recommended that all proposals be rejected.

The solicitation, for which the County has no current contract, was advertised on March 20, 2008, for one year with four, one-year options-to-renew and would have been awarded to the two, highest ranked, responsive and responsible proposers. The contract amount would have been \$1,328,000 for one year with a cumulative value of \$2,656,000 should the County exercise all options-to-renew.
