RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE APRIL 4, 2010 "EASTER ON BROADWAY" SPONSORED BY INNER CITY COMMUNITY DEVELOPMENT CORP., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$650.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 2 FY 2008-09 IN-KIND RESERVE FUND

**WHEREAS**, Inner City Community Development Corp. has requested in-kind services from the Miami-Dade Park and Recreation Department for the April 4, 2010 "Easter on Broadway" in an amount not to exceed \$650.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the "Easter on Broadway" is an all-day outdoor festival featuring live music, an Easter egg hunt and other activities; and

**WHEREAS**, Inner City Community Development Corp. is a not-for-profit organization; and

**WHEREAS**, the "Easter on Broadway" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$650.00 of the in-kind services shall be funded from the unspent balance of the District 2 FY 2008-09 In-kind Reserve Fund,

## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Inner City Community Development Corp., for their "Easter on Broadway" event held on April 4, 2010.

In-kind services have been requested in an amount not to exceed \$650 from the Miami-Dade Park and Recreation Department for the use of a 16'X16' stage. This event will be funded from the unspent balance of the District 2 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Inner City Community Development Corp. received \$21,250 from the general fund for elderly services. In addition, as part of Resolution 270-10, they received \$790 from the District 2 in-kind reserve.
