Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The countywide and fire district in-kind reserve balances allow for the funding of this request.

Background

A retroactive waiver for in-kind services is being requested by a not-for-profit organization, City of North Miami, for their "Independence Day by the Bay Celebration" event held on July 4, 2010.

In-kind services have been requested in an amount not to exceed \$700.00 from the Miami-Dade Fire and Rescue Department for assistance to cover the cost or to waive the service fees at the Conference Center at Florida International University, Biscayne Bay Campus. The in-kind amount totals \$700.00. This event will be funded in part from the countywide in-kind reserve fund and in part from the non-ad valorem in-kind reserve of the Fire Rescue District Budget.
