

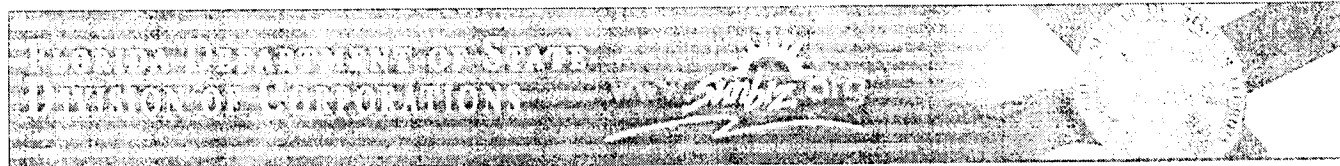

## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Belafonte Tacolcy Center, Inc., for their "Small Business and Entrepreneurial Showcase 911" event held on September 11, 2010.

In-kind services have been requested in an amount not to exceed \$2,500 from the Miami-Dade Park and Recreation Department for the use of a large showmobile. This event will be funded from the unspent balance of the District 3 FY 2008-09 in-kind reserve fund.

In FY 2009-10, Belafonte Tacolcy Center, Inc., received \$41,965 from the General Fund for social and cultural enhancements, as well as for operational support.
