

## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A waiver for in-kind services has been requested by a for-profit organization, Skyward Kites, Inc. for "Kite Festival" event to be held on February 19 – 20, 2011.

In-kind services have been requested in an amount not to exceed \$2,600.00 from the Miami-Dade Park and Recreation Department for the use of two small showmobiles. This event will be funded from the unspent balance of the District 4 FY 2008-09 in-kind reserve fund.

In FY 2010-11, Skyward Kites, Inc., received no funding for this event.
