

RESOLUTION APPROVING THE CITY OF MIAMI CO-  
DESIGNATION OF NW 28<sup>TH</sup> STREET FROM NW 17<sup>TH</sup>  
AVENUE TO NW 21<sup>ST</sup> AVENUE AS "RADIO PAZ WAY"

**WHEREAS**, on October 14<sup>th</sup>, 2010, the City of Miami Commission adopted Resolution R-10-0453, which designated NW 28th Street from NW 17<sup>th</sup> Avenue to NW 21<sup>st</sup> Avenue as "Radio Paz Way," a copy of which is attached and incorporated by reference; and

**WHEREAS**, Radio Paz was founded by Father Federico Capdepon in December 1990 with a two hour program called "Amanecer"; and

**WHEREAS**, in 1996, Radio Paz began 24-hour daily programming, being the first Spanish-language Catholic radio station in the U.S.; and

**WHEREAS**, NW 28<sup>th</sup> Street from NW 17<sup>th</sup> Avenue to NW 21<sup>st</sup> Avenue is a city street located in the City of Miami; and

**WHEREAS**, the City of Miami has requested that the County install signage indicating this co-designation on County street signs and traffic signal masts arms; and

**WHEREAS**, this co-designation is located in County Commission District 3,

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA**, that this Board:

**Section 1.** Approves the City of Miami co-designation of NW 28<sup>th</sup> Street from NW 17<sup>th</sup> Avenue to NW 21<sup>st</sup> Avenue as "Radio Paz Way".

**Section 2.** Directs the Clerk of the Board to send certified copies of this Resolution to the City Manager of the City of Miami the U.S. Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works

Department, the City of Miami Police Department, and the City of Miami Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Vice Chairwoman Audrey M. Edmonson.

It was offered by Commissioner **Rebeca Sosa**, who moved its adoption. The

A RESOLUTION OF THE MIAMI CITY COMMISSION CODESIGNATING NORTHWEST 28TH STREET FROM NORTHWEST 17TH AVENUE TO NORTHWEST 21ST AVENUE, MIAMI, FLORIDA, AS "RADIO PAZ WAY;" FURTHER DIRECTING THE CITY MANAGER TO INSTRUCT THE DIRECTOR OF PUBLIC WORKS TO TRANSMIT A COPY OF THIS RESOLUTION TO THE HEREIN DESIGNATED OFFICES.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF MIAMI, FLORIDA:

Section 1. Northwest 28th Street from Northwest 17th Avenue to Northwest 21st Avenue, Miami, Florida, is codesignated as "Radio Paz Way".

Section 2. The City Manager is directed to instruct the Director of Public Works to transmit a copy of this Resolution to the Departments of Police, Fire-Rescue, Solid Waste, Miami-Dade County Public Works, and the United States Postal Service.

Section 3. This Resolution shall become effective immediately upon its adoption and signature of the Mayor.{1}

Footnotes:

{1} If the Mayor does not sign this Resolution, it shall become effective at the end of ten calendar days from the date it was passed and adopted. If the Mayor vetoes this Resolution, it shall become effective immediately upon override of the veto by the City Commission.
