

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE NOVEMBER 21, 2010 "THANKSGIVING FESTIVAL" SPONSORED BY CURLEY'S HOUSE OF STYLE, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$3,100.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 3 FY 2008-09 IN-KIND RESERVE FUND

**WHEREAS**, Curley's House of Style, Inc., has requested in-kind services from the Miami-Dade Park and Recreation Department for the November 21, 2010 "Thanksgiving Festival" in an amount not to exceed \$3,100.00 (see attached Fee Waiver/In-kind Service Application); and

**WHEREAS**, the "Thanksgiving Festival" was a celebration of Thanksgiving which was open to the public; and

**WHEREAS**, the Curley's House of Style, Inc., is a not-for-profit organization; and

**WHEREAS**, the "Thanksgiving Festival" was a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$3,100.00 of the in-kind services shall be funded from the unspent balance of the District 3 FY 2008-09 In-kind Reserve Fund,





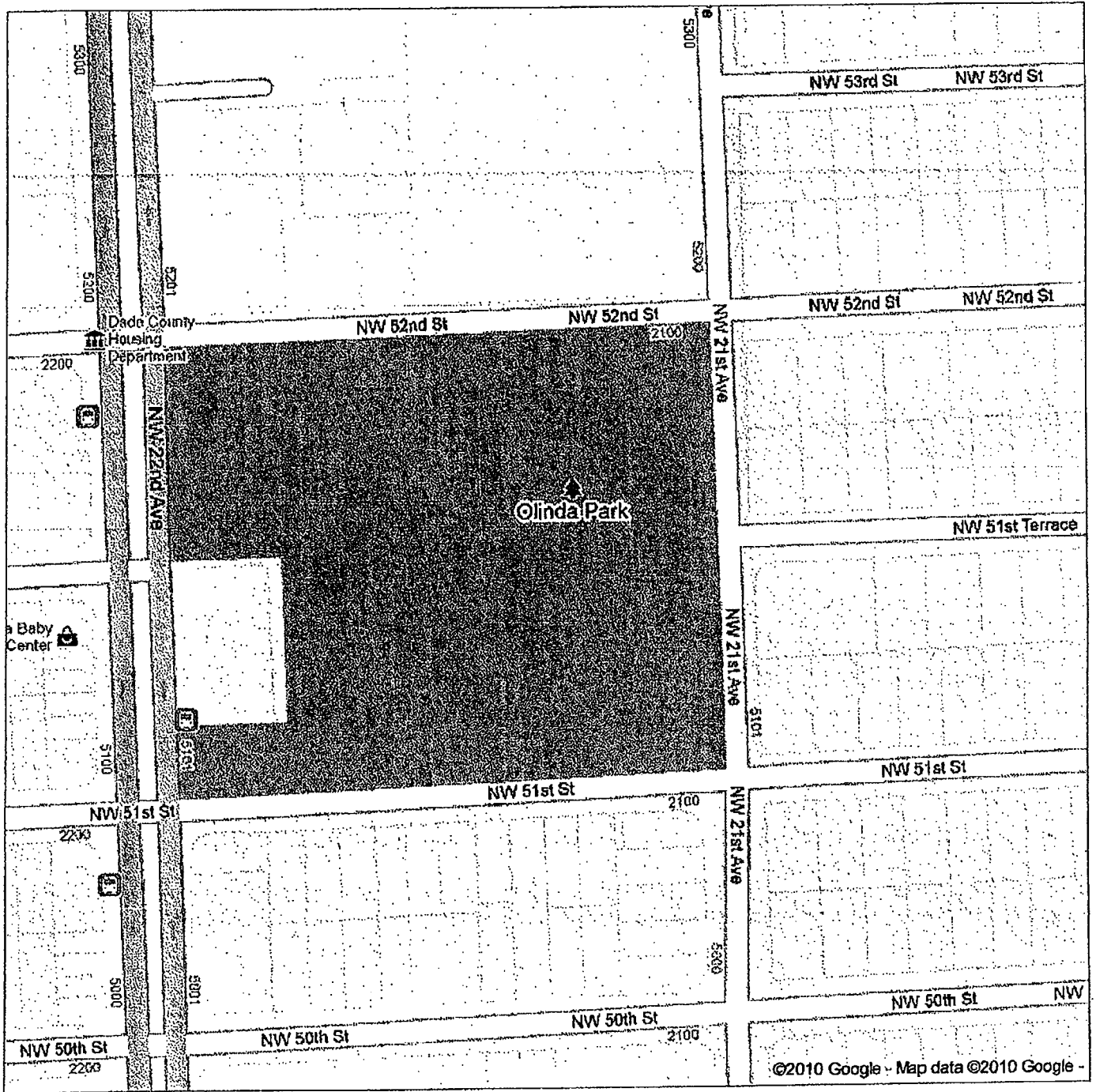

## Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

## Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, Curley's House of Style, Inc., for their "Thanksgiving Festival" held on November 21, 2010.
