

RESOLUTION NO. _____ R-273-11

RESOLUTION CALLING SPECIAL ELECTION IN MIAMI-DADE COUNTY, FLORIDA, TO BE HELD ON TUESDAY, MAY 24, 2011, FOR THE PURPOSE OF SUBMITTING TO QUALIFIED ELECTORS OF MIAMI-DADE COUNTY THE CANDIDATES TO FILL THE VACANCY IN THE OFFICE OF COUNTY COMMISSIONER FOR DISTRICT 7, AND IF NECESSARY A SPECIAL RUN-OFF ELECTION TO BE HELD ON TUESDAY, JUNE 28, 2011

WHEREAS, the Office of County Commissioner for District 7 is now vacant; and

WHEREAS, Section 1.07 of the Home Rule Charter, requires that vacancies in the office of County Commissioner “shall be filled by majority vote of the remaining members of the Board within 30 days, or the Board shall call an election to be held not more than 45 days thereafter to fill the vacancy;” and

WHEREAS, the Board desires to fill these vacancies by special election held on Tuesday, May 24, 2011 and, if necessary, by a run-off election held on Tuesday, June 28, 2011,

NOW, THEREFOR, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that:

Section 1. In accordance with the provisions of the Miami-Dade County Home Rule Charter and the Code of Miami-Dade County, a special election is hereby called and shall be held in Miami-Dade County, Florida on Tuesday, May 24, 2011, for the purposes of submitting to the qualified electors of County Commission District 7 the candidates to fill the vacancy in the Office of County Commissioner for District 7. If necessary, a special run-off election will be held on Tuesday, June 28 2011.

Section 2. Notice of such election shall be published in accordance with Section 100.342, Florida Statutes.

Section 3. Candidate qualifying for Miami-Dade County Commissioner, District 7, shall commence at noon on April 13, 2011, and end at 5:00 p.m. on April 14, 2011.

Section 4. The result of such election shall be determined by the qualified electors residing within County Commission District 7 voting on the candidates. The polls at such election shall be open from 7:00 a.m. until 7:00 p.m. on the day of such election.

Section 5. All qualified electors of Miami-Dade County Commission District 7 shall be entitled to vote for the Commission District 7 vacancy election. The County registration books shall remain open at the Office of the Miami-Dade County Supervisor of Elections until twenty-nine (29) days prior to the date of such election, at which time the registration books will close in accordance with the provisions of general election laws.

Section 6. The form of the ballot for these elections shall be in accordance with the requirements of general election laws.

Section 7. Early voting for these elections shall be conducted in accordance with the requirements of general election laws. A total of twenty (20) early voting sites will be used during this election.

Section 8. Absentee paper ballots for these elections may be used by qualified electors of Miami-Dade County for voting on this question. The form of such absentee ballot shall be in accordance with the requirements prescribed by general election laws.

Section 9. A sample ballot showing the manner in which the question or proposal aforesaid will appear at this election shall be published and provided in accordance with the applicable provisions of general election laws.

Section 10. These special elections shall be held and conducted in accordance with applicable provisions of the general laws relating to elections and the provisions of the Miami-Dade County Home Rule Charter. The County Mayor or his or her designee, the Finance Director, and the Clerk of the County Commission are hereby authorized and directed to take all appropriate actions necessary to carry into effect and accomplish the provisions of this resolution. This election shall be a nonpartisan election. Election officials in connection with this election shall be appointed in accordance with the provisions of general election laws.

Section 11. This election shall be canvassed by the County Canvassing Board, in accordance with the provisions of Section 3.07 of the Home Rule Charter.

The Prime Sponsor of the foregoing resolution is Chairman Joe A. Martinez. It was offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Sally A. Heyman** and upon being put to a vote, the vote was as follows:
