

RESOLUTION RETROACTIVELY AUTHORIZING IN-KIND SERVICES FROM THE MIAMI-DADE PARK AND RECREATION DEPARTMENT FOR THE APRIL 30, 2011 "MARCH FOR BABIES" SPONSORED BY THE MARCH OF DIMES FOUNDATION, INC., A NOT-FOR-PROFIT ORGANIZATION, IN AN AMOUNT NOT TO EXCEED \$500.00 TO BE FUNDED FROM THE UNSPENT BALANCE OF THE DISTRICT 4 FY 2008-09 IN-KIND RESERVE FUND

WHEREAS, the March of Dimes Foundation, Inc. has requested in-kind services from the Miami-Dade Park and Recreation Department for the April 30, 2011 "March for Babies" in an amount not to exceed \$500.00 (see attached Fee Waiver/In-kind Service Application); and

WHEREAS, the "March for Babies" is the largest fundraiser for the March of Dimes; and

WHEREAS, the mission of the March of Dimes is to help give all babies a healthy start; and

WHEREAS, March of Dimes Foundation, Inc. is a not-for-profit organization; and

WHEREAS, the "March for Babies" is a district event, as that term is defined on the attached Fee Waiver/In-kind Service Application, and \$500.00 of the in-kind services shall be funded from the unspent balance of the District 4 FY 2008-09 In-kind Reserve Fund,

Subject: District Specific In-Kind Reserve Request Recommendation

Recommendation

The Office of Strategic Business Management (OSBM) reviewed the attached in-kind request and recommends this item move forward to the Board of County Commissioners for consideration. The district specific in-kind reserve balance allows for funding of this request.

Background

A retroactive waiver for in-kind services has been requested by a not-for-profit organization, March of Dimes Foundation, Inc., for the "March for Babies" event held on April 30, 2011.

In-kind services have been requested in an amount not to exceed \$500 from the Miami-Dade Park and Recreation Department for Crandon Park personnel expenses. This event will be funded from the unspent balance of the District 4 FY 2008-09 in-kind reserve fund.

In FY 2010-11, March of Dimes Foundation, Inc., received \$600 from District 4 office funds and \$5,000 from District 12 office funds.
