

RESOLUTION NO. _____ R-427-11

RESOLUTION CO-DESIGNATING THE PORTION OF SW
99TH STREET, FROM SW 162ND AVENUE TO SW 104TH
STREET, AS “CHRISTINA M. EVE ELEMENTARY SCHOOL
WAY”

WHEREAS, when the Miami-Dade County Public School system began desegregating, in 1969, Christina Eve became the first black principal of an all-white school at Treasure Island Elementary; and

WHEREAS, Ms. Eve has received recognitions by two Florida governors, Bob Graham and Lawton Chiles, for her accomplishments in the field of education and was listed in the publication “Who’s Who in Education”; and

WHEREAS, on November 9, 2000, a new elementary school located at 16251S.W. 99th Street was named the Christina Eve Elementary School in honor of Ms. Eve and her contributions to the community and education in Miami-Dade County; and

WHEREAS, over the years, Christina Eve Elementary School has lived up to the high standards set by Ms. Eve by achieving many outstanding awards, such as: the Golden School Award from 2000 – 2006; first place in the Sunshine State Battle of the Books Award in 2005, 2006 and 2007; first place in the Student United Way Award in 2005, 2006 and 2007; and recognition by the American Hispanic Educators Association of Dade for superior academic performance in a dual language program for 2005 – 2006; and

WHEREAS, in recognition of Christina Eve Elementary School’s extraordinary achievements, SW 99th Street from SW 162nd Avenue to SW 104th Street should be co-designated “Christina M. Eve Elementary School Way”; and

WHEREAS, this proposed co-designation is a county road located in County Commission District 11,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that this Board:

Section 1. Having conducted a public hearing, co-designates the portion of SW 99th Street from SW 162nd Avenue to SW 104th Street as "Christina M. Eve Elementary School Way."

Section 2. The Clerk of the Board is directed to send certified copies of this Resolution to the United States Postal Service, the Traffic Signals and Signs Division of the Public Works Department and Land Development Division of the Public Works Department, the Miami-Dade Police Department, and the Miami-Dade Fire Rescue Department.

The Prime Sponsor of the foregoing resolution is Chairman Joe A. Martinez. It was offered by Commissioner **Jose "Pepe" Diaz**, who moved its adoption. The motion was seconded by Commissioner **Joe A. Martinez** and upon being put to a vote, the vote was as follows:
