## RECOMMENDATION

It is recommended that the Board of County Commissioners approve award of this contract to American Fasteners Corporation to purchase nuts and bolts inventory services for the Miami-Dade Transit Department.

**CONTRACT NUMBER:** 7038-2/18  
**CONTRACT TITLE:** Nuts and Bolts Inventory Services  
**TERM:** Three years with two, two-year option-to-renew  
**APPROVAL TO ADVERTISE:** December 29, 2010  
**METHOD OF AWARD:** To the responsive and responsible bidder offering the lowest price on all items in the aggregate.  
**PREVIOUS CONTRACT AMOUNT:** \$100,000 for 14 months  
**CONTRACT AMOUNT:** \$89,000 for the initial three-year term  
\*If the County chooses to exercise the two, two-year options-to-renew, the cumulative value will be \$221,000. This amount includes price adjustments, based on consumer price index, which may be granted during the original term or option-to-renew periods.

**BACKGROUND**

This contract is for purchase of nuts and bolts inventory services for the Miami-Dade Transit Department (MDT). The vendor will furnish, deliver, replenish, and maintain inventory of nuts, bolts, screws, and fasteners at several MDT maintenance facilities used for the repair of bus, rail and mover vehicles by MDT mechanics. Storage bins at each maintenance facility are replenished by the vendor to ensure availability of these necessary items at all times.

The reduction in contract allocation is due to decreases in estimated quantities and projected usage based on the released amounts for the past five years for the current contract. MDT has confirmed that no Federal funds will be used for this contract.


