

RESOLUTION NO. R-692-11

RESOLUTION REQUIRING THAT SIGNS BE POSTED AT THE MIAMI INTERMODAL CENTER (MIC) ADVISING VISITORS THAT CAR RENTAL AGENCIES CHARGE ADMINISTRATIVE FEES FOR PROCESSING TOLLS

WHEREAS, car rental agencies operating out of the Miami Intermodal Center charge administrative fees to their customers for processing tolls; and

WHEREAS, the County is the owner of the Miami Intermodal Center; and

WHEREAS, customers may not be aware of this fee prior to renting a car,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF MIAMI-DADE COUNTY, FLORIDA, that signs shall be posted at and in the Miami Intermodal Facility advising visitors that car rental agencies may charge administrative fees for processing tolls.
